61.1 MINUTES - MEETING NO 60 - 21st FEBRUARY 2011

It was proposed by Alderman Campbell, seconded by Councillor Finlay and **AGREED:**

that the minutes of Meeting No 60 – 21st March 2011, as circulated, be confirmed as a correct record.

61.2 THE PLANNING (GENERAL DEVELOPMENT) (AMENDMENT) ORDER (NORTHERN IRELAND) 2011

The Department of Environment has made the above Statutory Rule, the main purpose of which is to amend the Planning (General Development) Order (NI) 1993 (SR 1993 No. 278). Its effect will be to increase the scope of householder development that no longer needs planning permission including small house extensions and conservatories, roof alterations, porches, sheds and green houses, oil and gas storage containers and chimneys, flues and decking. The new arrangements will also introduce new domestic permitted development rights for renewable energy technologies such as solar panels, heat pumps and biomass fuel storage containers. The new and revised permitted development rights will be subject to specified limitations and conditions.

New public information guidance entitled "Your Home and Planning Permission" to assist householders and developers in their understanding of the new arrangements is available from planning offices and can be viewed online at www.planningni.gov.uk from 6th April.

61.3 PLANNING BILL – TRANSFER OF PLANNING FUNCTIONS

The Planning Bill completed its passage through the Assembly at the end of March. This provides the framework for the transfer of planning functions to local government. This will happen after new governance arrangements for councils and a new ethical standards regime for councillors, which is currently out for consultation, have been put in place.

As part of the transformation of Planning Service its status as an Agency within DOE ended on 31st March 2011. From 1st April Planning Service's functions and staff have been absorbed into the core of DOE. Planning functions have also been reorganized to anticipate the transfer to councils. This will mean a Local Planning Division taking operational responsibility for the development plan and development functions that will, in due course, transfer from the Department to Councils. A Strategic Planning Division will take forward the responsibilities which will remain with the Department following local government reform.

There will be some managerial changes within both the Local and Strategic Planning Divisions, with some changes to the Council districts each Area Planning Manager will be responsible for. A list of Area Planning Managers and the council districts is attached at Annex A and Annex B.

61.4 ENVIRONMENTAL BETTER REGULATION WHITE PAPER - CONSULTATION

The Department of Environment is seeking views on this White Paper. The consultation is in four areas – better permitting; enforcement and inspection powers; administrative penalties and sanctions; and criminal penalties and sanctions. It is the intention that during the consultation period the Department will bring forward specific policy proposals and will consult on each of these areas. Comments are invited by 30th September. The document can be viewed at http://www.doeni.gov.uk. A copy of the document is available from the Office of the Chief Executive.

61.5 REVIEW OF OFF-STREET PARKING CHARGES

The Department of Regional Development Minister has considered and approved the following car park charges in the Councils area.

- Castle Street increase in charge from 30p for up to 3 hours to 60p for up to 6 hours and 90p all day to a charge of 20p per hour or part thereof.
- Church Street charges to increase from 30p per hour to 40p per hour

The Department will advertise a notice in the local press once the order has been made. This notice will show the changes in tariffs and the date the new tariffs will come into effect.

The key consideration used in setting the new charges are:

- The need to influence where drivers park, allowing for higher turnover of short stay spaces and therefore an increase in the availability of short stay parking in support of the commercial viability of the town centre.
- The need to make efficient use of the existing car park provision.
- The history of tariff increase in the town.
- The need for charges to reflect increased costs. For example, rates bills, which are a major component of the cost of operating a pay car park.
- The need to fully recover the cost of providing the car park services. This is in line with DFP guidance in Managing Public Money in NI.
- The level of charges in other regional towns and comparable or smaller size. The Department state that it is worth noting that car parks currently on the 30p per hour tariff will move to the 40p hour tariff. The 30p tariff has been the general charge in provincial towns for more than 10 years. The increase is being applied throughout NI.

61.6 ROADS SERVICE REPORTS TO COUNCIL 2011

As members know it is usual that Roads Service present two reports to Council, one in late spring and one in late autumn. This year, in view of the timing of Council and Assembly elections and the preceding Purdah period, to prepare, distribute and deliver eight Council reports in the short space in the lead in to the summer holiday period, while not insurmountable, is presenting some administrative difficulties for Roads Service. In addition, while the overall level of Roads Service Corporate budgets will be known before the new financial year begins it is likely that divisional budgets may not be finally confirmed until much later than normal this year. It is suggested that this year, one meeting in early Autumn would be more convenient and more informative to councillors, in that Roads Service would have confirmed budgets and programmes.

It was proposed by Councillor Finlay, seconded by Councillor Kennedy and AGREED:

that Council write to Roads Service advising that whilst two meetings per year are preferable, due to exceptional circumstances, one meeting in (preferably early) Autumn of 2011 is acceptable.

Proposed demolition of existing offices at 60 Eastermeade Gardens and construction of new building providing 3 no. supported living accommodation units. Alternation of 33 Charlotte Street to provide 2 no. supported living accommodation units for Triangle Housing Association Ltd.

It was **AGREED**: That an office meeting be held (Councillor Finlay).

At the request of Councillor Stevenson, the Planning Officer clarified the differing conditions enforced by NI Environment Agency for historic buildings to those applications in conservation areas stating the importance of maintaining conservation areas unless buildings are deemed unsafe or there is a public safety issue.

Item No 2 - D/2008/0299/LB - Refusal

Retention of front façade and demolition of remaining elevations and construction of cavity walls to provide 2 no. supported living accommodation units for 33 Charlotte Street, Ballymoney.

It was **AGREED:** That an office meeting be held (Councillor Finlay).

This application is associated with Item 1.

Item No 3 - D/2010/0295/F

Demolition of 2no existing properties and proposed construction of nursing/EMI care home at 15-17 Coleraine Road, Ballymoney for St James Lodge, Co/o Fleming.

Alderman Campbell and Councillor Stevenson welcomed the decision of the Department to approve the application. Councillor Robinson regretted earlier application for a hotel was not approved.

Item No 4 - D/2010/0313/F - Refusal

Proposed shed for storage and servicing of lorries at 75m SE of 346 Craigs Road, Rasharkin for MilkTrans, C/O Palmtree Creations.

It was **AGREED:** That an office meeting be held (Councillor Finlay).

Item No 5 - D/2010/0342/F - Refusal

Extension and alternations to existing garage at 95A Bravallen Road, Ballymoney for John Fynes.

It was **AGREED:** That an office meeting be held (Councillor Finlay).

Item No 6 - D/2010/0350/F - Refusal

Proposed sub-division of car showroom to form two retail units at former premises of Phillip Peterson Car Showroom, Model School Road, Ballymoney for Maurice Scott, Drum Irish Properties.

It was **AGREED:** That an office meeting be held (Councillor Kennedy).

Councillor Kennedy expressed disappointment in the decision stating that businesses previously operated successfully in what is considered to be the main thoroughfare out of the town and that these premises are served by their own car parking facilities. He requested Planning Service reconsiders the application referring to the benefits of subdivision to both the applicant and the area in the current economic climate. Councillors Finlay, Stevenson and Robinson supported the Mayor's comments.

At the request of Councillor Cavlan, the Planning Officer advised that the condition will be monitored and that no objection letters had been received.

Item No 4 - D/2010/0338/O - Refusal

Unable to agree proposal following office meeting. The Planning Officer agreed to hold the application to enable the applicant to withdraw. Alderman Connolly stated the applicant's intention to appeal the decision.

It was proposed by Alderman Connolly, seconded by Councillor Finlay and AGREED:

that Council support the applicant in his appeal against the decision to refuse the application.

61.10 DEVELOPMENT COMMITTEE REPORT

The Head of Corporate & Development Services presented the report.

10.1 Interreg IVA (NEP)

The Intereg IVA Tourism Measure call due to open on 8th February has been postponed and to date no revised opening date has been advised. The funding available is £9.5M. In preparation for the call opening and in the light of the amount of resource time required to prepare applications, NEP officer representatives met on 12th April to review previously rejected applications, to receive feedback from discussions with SEUPB, NITB and Failte Ireland and to discuss proposed new applications.

It was agreed that the best way forward, in the light of the resource input necessary, was to engage a consultant to review the existing proposal for biker tourism project and further develop in consultation with the officer team, to include additional theme(s) eg myths & legends on which work had already been advanced by Causeway Coast & Glens RTP, and to consult with other partner organizations.

It is **recommended** [a] that Council approve a joint procurement exercise for a consultant to develop the regional tourism proposal, at estimated cost to Council of £500 and [b] that Council agree to the procurement exercise being undertaken by Ballymena Borough Council through their procurement procedures, based on their select list of economic development consultants.

At the request of Councillor Robinson, the Head of Corporate and Development Services advised that no budget provision has been made and that a report relating to the funding will be made to the Committee in the near future.

It was proposed by Councillor Finlay, seconded by Councillor McCamphill and **AGREED:**

[a] that Council approve a joint procurement exercise for a consultant to develop the regional tourism proposal, at estimated cost to Council of £500 and

[b] that Council agree to the procurement exercise being undertaken by Ballymena Borough Council through their procurement procedures, based on their select list of economic development consultants.

10.2 Rural Development Programme

Following meeting with Officers from Village Renewal Programme and Sustainable Communities and Director of Borough Services regarding the Cloughmills Village Project it is **recommended** that applications be submitted for feasibility Study of Council owned site at Old Mill £5,000, for which match funding of 25% is required and also for Cloughmills Play Area for funding provision has been made in Borough Services Amenities projects budget.

The Director of Borough Services emphasized the need to undertake the feasibility study in order to provide information on how to fully utilize the site.

It was proposed by Councillor McCamphill, seconded by Councillor Finlay and AGREED:

that applications be submitted for feasibility Study of Council owned site at Old Mill £5,000, for which match funding of 25% is required and also for Cloughmills Play Area for which funding provision has been made in Borough Services Amenities projects budget.

MATTERS FOR CONSIDERATION ENVIRONMENTAL SERVICES

The Director of Borough Services presented the report at the meeting as the Committee meeting which should have been held in April had been inquorate. He advised that item 3 of the report (brown bin service) would be deferred until a further meeting of Committee.

It was proposed by Councillor Cavlan, seconded by Councillor Finlay and AGREED:

FOOD CONTROL

11.1 FOOD HYGIENE RATING SCHEME (FHRS)

Consistent implementation and operation of the Food Hygiene Rating Scheme (FHRS) is critical to ensuring that consumers are able to make meaningful comparisons of food hygiene ratings for businesses both within a single local authority area and across different local authority areas. It is also critical to ensuring that businesses are treated fairly and equitably.

The FSA and local authorities participating in the FHRS both have a role to play in achieving such consistency. In order to demonstrate commitment to working in partnership and fulfilling their respective responsibilities, the FSA and each participating local authority are required to sign a formal agreement. The agreement is based on the 'Brand Standard' for the FHRS which, in effect, is the guidance provided by the FSA. The aim is to ensure that where establishments are rated under the FHRS and where consumers see the FHRS branding, they can be confident that the local authority is operating the FHRS as the FSA intends.

A copy of the outline of responsibilities was circulated.

IT IS RECOMMENDED that Ballymoney Borough Council sign the agreement to implement and operate the Food Hygiene Rating Scheme. **IT IS FURTHER RECOMMENDED** that the Chief Executive be appointed to sign the agreement on behalf of Ballymoney Borough Council.

The applicants and their agents in all cases have been issued with Notices of Rejection of Plans, setting out the reasons for rejection, as required under Article 13 of the Building Regulations (Northern Ireland) Order 1979.

The applicants and their agents have also been notified of their right to appeal, within 56 days, to the Department of Finance and Personnel, as required under Article 17 of the Building Regulations (Northern Ireland) Order 1979.

11.12 REPLACEMENT RCV

Further to the provision made by Council for 2011-2012 work is on-going as regards the preparation of a specification for the purchase of a replacement refuse collection vehicle. It is anticipated that tenders will be invited later this month so that same might be returned and opened and report made to the May Committee meeting.

11.13 RETHINK WASTE PROJECT FUNDING

Council was recently successful in obtaining funding for four schemes through the Department of the Environment's Rethink Waste campaign. In addition, Council also helped Cloughmills Community Action Team secure funding for a food waste project.

All projects have been implemented, with funding obtained used as follows:

- Installation of concrete wall units at Crosstagherty Waste Handling & Transfer Facility to enable bulking up of timber. There are now dedicated skips at Knock Road and Crosstagherty Household Recycling Centres for the collection of timber. Since the inception of this service in November 2010, 113 tonnes of timber have been diverted from landfill.
- Installation of a static compactor for food and bagged waste at Crosstagherty Household Recycling Centre. This assists in establishing a mindset of waste separation at this recycling centre and ensures food waste no longer contaminates bulky household waste sent for sorting and diversion from landfill.
- New signage and branding across all Council recycling centres. The
 former civic amenity sites are now rebranded as household recycling
 centres, highlighting the growing emphasis on waste separation and
 recycling, rather than waste disposal. All community and supermarket
 recycling centres also have new signage. Poster holders have been
 erected at the community recycling centres so that information on council
 recycling services can be displayed.
- A communications campaign raising the profile of reducing and reusing waste, rather than simply recycling waste generated. Through this, Council purchased new Agripa advertising panels for refuse collection vehicles promoting blue bins and the reduce, reuse, recycle message. Also purchased were display materials for educational work with schools and community groups, and two advertisements in the local newspapers outlining all the waste management options available across the Borough.

Incredible Edible Cloughmills

In addition, Council collaborated with Cloughmills Community Action Team under the Incredible Edible Cloughmills umbrella on a food waste project. Key elements of the project include:

• Display materials – pop up banners, street banners and car stickers.

 Promotional items – biodegradable water bottles, pens, food clips, plastic lids, shopping bags and aprons.

- Workshops with schools on 'waste free lunches'.
- Development of a website <u>www.incredibleediblecloughmills.eu</u>. This will showcase the project and its activities.
- Production of a story book 'Shall I put this in the bin?'
- Meetings to discuss how to maximise the impacts of local food production and consumption.

These projects all represent efforts being made to encourage Borough residents to think of waste as a resource and landfill as a last resort. It is hoped that householders and the wider community will use the Council's recycling facilities and services to their maximum potential.

11.21 BALLYMONEY AFFORDABLE FUEL SCHEME

26,900 oil stamps were sold between April 2010 and March 2011 to the value of £134,500. This was a 56% increase on the previous year.

The Oil Stamps Savings Cards have been redesigned this year to allow oil companies the opportunity of advertising their name, telephone number and logo on the cards at a cost of £100 per company for the year.

12 companies have chosen to advertise which will provide funding towards the cost of this year's cards and oil stamps.

61.12 VAT TREATMENT OF COMMERCIAL WASTE COLLECTION SERVICES PROVIDED BY LOCAL AUTHORITIES

Further to Minute HES369.18 (22nd February 2011), the Director advised that written confirmation had now been received that following the review of the VAT treatment of local authority commercial waste collection services by HM Revenue & Customs "this has led us to conclude that these services are outside the scope of VAT, whereas hitherto we have regarded them as taxable at the standard rate."

In light of the change in the VAT position consideration needs to be given to the following:-

- (1) stop accounting for VAT on trade waste services and
- (2) undertake preparatory work in order to submit by the end of June 2011 a claim to HMRC for overpaid VAT on trade waste income for the last 4 years.

IT IS RECOMMENDED that Committee endorse the above approach and make a recommendation to Council accordingly.

It was proposed by Councillor Cavlan, seconded by Councillor Robinson and AGREED:

that Council would

- (1) stop accounting for VAT on trade waste services and
- (2) undertake preparatory work in order to submit by the end of June 2011 a claim to HMRC for overpaid VAT on trade waste income for the last 4 years.

Committee is asked to note the following -

- HMRC is likely to resist payment of a 4 year claim (for overpaid VAT) and will mount a challenge on the grounds of unjust enrichment.
- One of the key aspects when considering unjust enrichment is the impact of VAT changes on pricing. Advice received by Finance indicates that keeping the prices at the "full cost" (inclusive of VAT) would improve the chances of a 4 year claim being paid by HMRC; however Council would also need to consider the likely impact of this on customers, particularly VAT registered businesses who presently can recover input VAT.
- It is the case that 2 neighbouring Councils have reduced their charges to their customers.

As invoices for trade waste services for the quarter January to March 2011 ought to have been issued but are presently delayed, it is necessary for Council to make a decision on trade waste charges in the light of the revised VAT position.

IT IS RECOMMENDED that Committee consider the matter and make recommendation to Council.

The Director of Borough Services and the Director of Central & Leisure Services responded to questions from members.
