8.1 Budget (199.6)

At the request of Alderman Simpson, the Head of Corporate & Development Services clarified the amount of funding committed to Programmes.

8.2 Addendum - Rural Development Programme

Members were reminded of DARD's decision to progress body corporate legislation for the Joint Committee through the Assembly's Agriculture Committee. They have now clarified that their reasons for going down this route were to improve the corporate governance of the programme and afford protection to individuals participating in joint committees. They state that a joint committee formed by councils without such legislation would have no legal identity of its own and all persons and councils involved could find themselves the subject of legal action at some point in the future. In addition, joint committees, such as currently exist for waste management, cannot deal with rural development as councils do not have the existing function to deal with rural development, that function lying with DARD under section 4 of the Agriculture (Miscellaneous Provisions) (NI) Order 1994 which provides that DARD may, with the approval of DFP, make grants for the purposes of encouraging rural development.

As a consequence of DARD's decision and in order to provide protection to the Department, the Councillors involved in the cluster and participating councillors, the Councils in the Rural Development Cluster (Ballymena, Ballymoney, Coleraine, Moyle and Larne) are being asked to apply to the Department to exercise the powers conferred by section 19(9) of the Local Government Act (NI) 1972 and form the cluster into a Joint Committee Body Corporate.

The role of the cluster group will be to act as lead financial actor to the local action group, providing administration, financial management, programme monitoring and advice to the local action group which is charged with responsibility for the establishment, promotion and implementation of the local rural development strategy and projects under Axis 3 of the Rural Development Programme 2007-2013. In fulfilling this role the Cluster groups will have a governance role in the oversight of the local action group's proposals for awarding financial assistance towards projects nominated for funding under eligibility criteria, terms and conditions of Axis 3 & 4 of the Programme.

It is recommended that the Chief Executive be authorised to sign on Council's behalf, an application to the Department to exercise the powers conferred by section 19(9) of the Local Government Act (NI) 1972 and form the cluster into a Joint Committee Body Corporate, (a similar application being made by all councils in the cluster).

It was proposed by Councillor Stevenson, seconded by Alderman Connolly and **AGREED:**

that the Chief Executive be authorised to sign, on Council's behalf, an application to the Department to exercise the powers conferred by section 19(9) of the Local government Act (NI) 1972 and form the cluster into a Joint Committee Body Corporate (a similar application being made by all councils in the cluster).

894.15 BUDDY BEAR TRUST

At Council meeting on 1st December, Council agreed to lend its support for the Trust's request for a meeting with the Education Minister to explore options in relation to the future of the school.

Dungannon & South Tyrone Borough Council has written following a decision by the Assembly to support conductive education and to commend the Buddy Bear School, Dungannon, to the Office of the First Minister, Deputy first Minister and the Minister of Education for financial support and assistance. A copy of the Assembly Report is available.

To facilitate a co-ordinated approach, Dungannon & South Tyrone Borough Council invite representatives from Council to an information session to address the future provision and choice of special conductive education for children with Cerebral Palsy and look at how Councils can lend their support. Ministers, Committee, MLA's and representatives from the relevant Government Departments will also be invited.

894.16 HM REVENUE & CUSTOMS CHANGE PROGRAMME PROPOSALS

In accordance with Section 75 of the Northern Ireland Act 1998, HMRC published an Equality Impact Assessment (EQIA) for its estate outside of the Belfast urban centre. This report outlines HMRC's decisions on the proposals and the ongoing mitigating

894.17 ROADS INVESTMENT – QUARRY PRODUCTS ASSOSICATION

The Quarry Products Association, in welcoming the urgency and leadership shown by the Executive and Assembly in relation to the wider construction industry, calls for support for the Executive as it steers a course to manage the Northern Ireland economy, stating that any financial package the Executive brings forward has investment in infrastructure as a key priority.

The Association states that current shortfall in funding for roads maintenance now stands at well over £500 million. We need a ring fenced index linked annual budget going forward of no less than that identified in the Roads Service structural maintenance funding plan.

894.18 MAGHERAFELT DISTRICT COUNCIL – AUTISM SPECTRUM DISORDER

The Council has written drawing attention to the apparent shortcomings of the consultative documents – Autism spectrum Disorder (ASD) Strategic Action Plan 2008/09 – 2010/11 – insofar as it has failed to address many of the very serious issues.

The Council has resolved to forward a copy of its comments to all Councils and requests Councils to endorse its response.

894.19 COLERAINE BOROUGH COUNCIL – PLANNING DECISION NOTICES

The Council's Planning Committee has considered the current procedure for issuing planning decisions, following the Planning Service's consultation with Council. It noted that, in the majority of cases, refusal notices were issued the day following the Council meeting, thus removing the opportunity for applicants/agents to withdraw their applications.

Whilst recognising the Department's strategic objectives in terms of providing an efficient and effective service to the public, they felt that the Department placed undue emphasis on meeting targets at the expense of effectiveness and fair play.

They have made representations to the Chief Executive of the Planning Service requesting that all refusal decisions be held for a 5 day period following Council consultation.

The support of the Chairman of the Environment Committee and the other 25 Councils is sought.
