**197.1 MINUTES OF MEETING NO. 196 on 15<sup>th</sup> September 2008**

It was proposed by Alderman Campbell, seconded by Councillor Finlay and **AGREED:**

***that the minutes of committee meeting, No. 196, on 15<sup>th</sup> September 2008, as circulated, be confirmed as a correct record.***

**197.2 PROGRAMME UPDATE**

Councillor Finlay reported on the recent visit by delegates from Vanves. He thanked the Head of Corporate and Development Services for her hard work and effort in organising and providing support for the visit.

Councillor Finlay also praised the work of the Twinning Association remarking on their successful dinner and fundraising efforts. He thanked the Councillors for their support.

The Head of Corporate and Development Services thanked Councillor Finlay for his kind remarks and support during their visit and acknowledged the work of others "behind the scenes".

\* **Councillor Cavlan and Alderman Cousley joined the meeting at 3.34pm.**

The Head of Corporate and Development Services presented the Programme Update adding information on further progress (attached as Appendix 1).

\* **Councillor Patterson joined the meeting at 3.35pm.**

A discussion followed on the preparation of capital projects and programmes by Councils, in preparation for the project call in January 2009. The main capital scheme submitted was Drumaheglis development.

In response to Councillor Finlay, the Chief Executive agreed to confirm the ranking of Drumaheglis Marina in the Corporate Plan. Councillor Finlay was keen that those projects with a ranking of 1 be completed prior to the addition projects but accepted that this funding opportunity should not be missed.

It was proposed by Councillor Finlay, seconded by Councillor McCamphill and **AGREED:**

***to recommend that consultancy support be secured to assist with project development and funding bids for the rural development programmes, cost being met from existing budget.***

In response to Councillor McCamphill, the Head of Corporate and Development Services confirmed that the town area is excluded from the programme. Retail businesses are also excluded from DETI and Interreg.

\* **Councillor Finlay left the meeting at 4.03pm.**

Alderman Campbell expressed his concerns regarding changing status of the partnership to a company limited by guarantee, under which members allegiance would be to company and not Council.

The LSP Project Officer has returned from maternity leave to her post until end of December 2008 when LSP will close. The final process of company closure will be completed by the Office of Chief Executive, after the closure of the LSP to comply with legal timetable.

The Head of Corporate and Development Services reported on a meeting held with Fuse FM who have obtained a broadcasting licence from 22 November 2008 to 20 December 2008 from the Music Centre Building and are interested in providing the

Christmas music in the town centre. Technical issues are currently being investigated.

Members noted the proposed Christmas entertainment by Council and other groups and a number of members welcomed the showcasing of local talent.

It was proposed by Alderman Campbell, seconded by Councillor McCamphill and **AGREED:**

***to recommend permission be given to Fuse FM to broadcast their shows in the Town Centre (22 November – 20 December 2008) during the usual times..***

\* **Alderman Simpson left the meeting at 4.29pm.**

The committee meeting was adjourned for 10 minutes and recommenced at 4.40pm.

Arising from discussion on townscape scheme Councillor McKeown requested that the Road Safety Committee be consulted on the proposals.

The Head of Corporate and Development Services agreed to include this Committee on the list of those to be consulted.

### **197.3 BALLYMONEY COMMUNITY RESOURCE CENTRE**

The Head of Corporate and Development Services reported that Ballymoney Resource Centre held an extraordinary general meeting in connection with their move to limited company status. Invitations were circulated for Board members. A copy of memorandums and articles is being examined to confirm if Council can participate under the legislative power available to it to form and participate in limited companies.

### **197.4 NORTH ANTRIM COMMUNITY NETWORK**

North Antrim Community Network emailed Council seeking support for a bid for funding from DARD. After consultation with the Chief Executive a letter has been sent, within the limited timescale available, confirming Council's financial support for the company and its operational plans which provide a wide range of services to groups in the Borough.

It was proposed by Alderman Campbell, seconded by Councillor Finlay and **AGREED:**

***to recommend Council endorse by formal letter of support to the North Antrim Community Network's bid to DARD for funding.***

\* **Councillor McCamphill left the meeting at 4.54pm.**

**197.5 PRESENTATION – COMMUNITY DEVELOPMENT UPDATE**

The Head of Corporate and Development Services presented a briefing to members on community support/services provided by Office of Chief Executive and the two directorates and support provided by other bodies. A copy of the Community Development Tree was circulated to members. (Attached as Appendix 2).

\* **Alderman Simpson joined the meeting at 5.05pm.**

Guidance was sought from members regarding the way forward. Given members desire to provide additional support to the community sector in development projects for the next round of EU funding.

\* **Alderman Simpson left the meeting at 5.32pm.**

After discussion it was agreed that options will be prepared to be considered by Committee.
