#### 323.1 MINUTES - MEETING NO 322 - 24th OCTOBER 2006

It was proposed by Alderman Campbell, seconded by Councillor Patterson and **AGREED**:

#### **ENVIRONMENTAL PROTECTION**

### 323.2 WATER (NI) ORDER 1999 APPLICATION FOR CONSENT TO DISCHARGE EFFLUENT

Notification has been received from EHS Water Management Unit advising that the undernoted application for consent to discharge effluent to a waterway has been made:

Northstone (NI) Ltd., Quarry & Asphalt Division, Long Mountain Depot, Ballycraig Quarry, Mullan Road, Finvoy, Ballymoney, BT53 7ED.

EHS Water Management Unit has also advised that the undernoted application for consent to discharge effluent to the underground stratum has been made:

93 Bridge Road, Dunloy, Ballymena, BT44 9EG.

As EHS will set levels as to the quality of effluent to be discharged, *IT IS RECOMMENDED* that Council note the applications.

It was proposed by Alderman Campbell, seconded by Councillor Kennedy and **AGREED**:

to recommend that Council note the above applications.

### 323.3 INDUSTRIAL POLLUTION CONTROL (NI) ORDER 1997 POLLUTION PREVENTION AND CONTROL REGULATIONS (NI) 2003

McGuckian Milling Company, 29 Drumbare Rd, Cloughmills, BT44 9LA. Chestnutt Animal Feeds, 55 Main Street, Stranocum, BT53 8PQ

The animal feed compounding processes at the above addresses are currently authorised under the Industrial Pollution Control (NI) Order 1997. The system of pollution control established by the Order is now being replaced by a new regime under the Pollution Prevention and Control Regulations (NI) 2003. These regulations require all prescribed processes to hold a permit to operate in place of the current authorisations.

The proposed permits for the above premises can be found at Appendix 1, and Appendix 2, to this report. These have been prepared having considered the information contained in the Process Guidance Note PG No. 6/26 relevant to the operation. The operators have had the opportunity to consider the conditions contained within the permits and make comments.

*IT IS RECOMMENDED* that approval be granted for the permits of a prescribed process under Regulation 10 of the above Ordinance to the said operators of the businesses in the form contained in the proposed permit, together with supporting plans and documents and that the annual subsistence fee be applied pro rata as required by statute.

It was proposed by Councillor Wilson, seconded by Councillor McCamphill and **AGREED**:

to recommend to Council that approval be granted for the permits of a prescribed process under Regulation 10 of the above Ordinance, to the said operators of the businesses, in the form contained in the proposed permit, together with supporting plans and documents and that the annual subsistence fee be applied pro rata as required by statute.

#### **ENVIRONMENTAL SERVICES**

#### 323.4 LANDFILL COMPACTOR TENDER

Information was received on 15<sup>th</sup> November that Derry City Council was inviting tenders for either the hire or purchase of a second hand 26 tonne landfill compactor. The Councils landfill compactor (which is surplus to requirements) has been offered to that authority for the sum of £12,000 plus transport plus vat by the deadline set: 12 noon, Friday, 17<sup>th</sup> November 2006.

Were Derry City Council to accept the offer made on the Councils behalf, *IT IS RECOMMENDED* that Council endorse the sale of its 26t landfill compactor for the sum of £12,000.

Respoding to a question from Alderman Campbell, the Director clarified the rationale in offering the equipment for sale rather than for hire. He also advised that Derry City Council had accepted the Council's tender offering to sell its landfill compactor. He also suggested that the proceeds of this sale be earmarked for environmental services purposes.

\* The Mayor, Councillor Finlay arrived at 7.45pm, apologising for his late arrival.

It was proposed by Councillor Kennedy, seconded by Alderman Campbell and **AGREED**:

to recommended that Council sell its 26t landfill compactor to Derry City Council for the sum of £12,000 plus transport costs and VAT and that the proceeds from the sale be earmarked for environmental services purposes.

\* Councillor McKay arrived at 7.50 pm.

#### 323.5 WASTE FRIDGES AND FREEZERS CONTRACT

The Director informed Members that the existing Northern Ireland contract to which Council was a party terminates on 31<sup>st</sup> December 2006 and that work had been undertaken over a number of months by a Management Board [on which he represented the NWRWM Group constituent councils] to set up a new contract to deal with waste fridges and freezers. He advised that another contract was necessary as the UK Government had not yet implemented its WEEE Directive obligations. As previously, were Council to enter into the new contract then it would be able to recycle waste fridges and freezers at no cost as the unit rate of £6.65 would be returned to Council by way of a grant. He further advised that the proposed contract would run initially for six months but would be extended as required.

The Director **RECOMMENDED** that Council participate in the proposed [NI Contract] Framework Agreement for the Management of Waste Fridges and Freezers to commence on 1<sup>st</sup> January 2007, with the service being provided by TechRec (NI) Limited [the successful bidder] at a unit rate of £6.65 per waste domestic fridge/freezer.

The Director also advised that this contract would also be used by Council to recycle waste commercial fridges/freezers which came into its possession either by way of dealing with fly-tipping or which were surreptitiously left at the Council's CA Sties. In response to a question he advised that Council did not offer a disposal service to the commercial sector, but would on request give details of service contractors.

It was proposed by Alderman Campbell, seconded by Councillor Finlay and **AGREED**:

to recommend that Council participate in the Framework Agreement for the Management of Waste Domestic Fridges and Freezers.

## 323.8 SERVICE LEVEL AGREEMENT FOR ENVIRONMENTAL HEALTH OFFICERS TO ENFORCE THE MANUFACTURE AND STORAGE OF EXPLOSIVES REGULATIONS (NI) 2006 – HAZARD TYPE 4 ARTICLES

A Service Level Agreement has been drawn up between the Northern Ireland Office and the Borough Council to enable Environmental Health Officers to enforce the above Regulations in respect of persons registered to store Hazard Type 4 Pyrotechnic Articles (fireworks) and Power Device Cartridges (air bags, nail guns, flares etc.). It is understood that there are three such premises within the Borough.

The agreement requires EHOs to carry out site inspections to ensure that the storage is in keeping with the guidance contained in the Approved Code of Practice and guidance accompanying the Regulations and provide a written report the NIO within 21 days from the date of issue of the request. Two interim inspections will be carried out during the three-year period of the registration to confirm that the site remains suitable and that the registered person remains fit on each occasion. A renewal inspection is to be completed and reported to the NIO prior to the expiry of the registration. The enforcement of the Regulations will be consistent with the policy set out in the current HSENI guidelines in relation to the Health and Safety at Work Order.

The fees for initial registration and renewal are £124 and £79 respectively and the Council will invoice the NIO on a quarterly basis for the work carried out. The fees are to be reviewed annually with any increases taking effect from 1<sup>st</sup> April. The Service Level Agreement will take effect from the 1<sup>st</sup> December 2006.

*IT IS RECOMMENDED* that the Borough Council enter into a Service Level Agreement (SLA) with the NIO with respect to the enforcement of the above regulations and that the Director of Borough Services be delegated to sign the (SLA) on behalf of Council.

At the request of members, the Director clarified issues of storage within the wholesale sector, advising that the use of such articles would be a matter for other bodies.

It was proposed by Councillor Wilson, seconded by Alderman Campbell and **AGREED**:

to recommend to Council that they enter into a Service Level Agreement with the NIO with respect to the enforcement of the above regulations and that the Director of Borough Services be delegated to sign the SLA on behalf of Council.

### 323.9 PROPOSALS FOR THE TRANSFER OF PETROLEUM LICENSING FUNCTIONS FROM DISTRICT COUNCILS TO HSENI

Proposals issuing from the Health & Safety Executive for Northern Ireland that it and not NI district councils should become the sole petroleum licensing authority for Northern Ireland have been received. In support of its proposals HSENI suggests such change is driven by (1) the Review of Public Administration, (2) the Hampton Review and (3) the Organised Crime Task Force.

The HSENI Consultative Document proposals ought to be rejected for the following reasons –

- 1. It is considered that the HSENI proposals are primarily driven by that largely unaccountable organisation's desire for self-preservation in the face of RPA, rather than for any other reason. Self-interest is no valid reason for making a change to a licensing/regulatory system, which has been operated successfully by local authorities since its inception in 1929. The proposals run contrary to RPA and not as HSENI would contend in support of the present on-going process. No substantive case is made by HSENI to justify its wish to 'empire build' at the expense of local democracy by removing this type of licensing from NI district councils. RPA is about enhancing local government, providing additional responsibilities and democratic accountability, not the reverse proposed by HSENI. The removal of function to it, a next steps agency and thereby increasing both public service fragmentation and the extant democratic deficit ought not to be condoned.
- 2. If the proposals are consistent with the Hampton Review recommendations, as it has suggested, why are there no proposals elsewhere in the United Kingdom to remove responsibility for petroleum licensing from local authorities there? It is clearly the case that the HSENI proposals, rather than reducing the administrative burdens on businesses will have the opposite effect. Were HSENI to become the sole petroleum licensing authority for Northern Ireland, then it would be an additional enforcing authority with which proprietors of petroleum filling stations would have to contend. For this not to be the case HSENI would need to take over from district councils their responsibilities for food safety, health & safety and environmental protection. Contrary to Hampton, administrative burdens on businesses would not be reduced, as the regulatory regime would become more fragmented and be made more complicated were the HSENI proposals to be implemented.

3. The HSENI proposal that were it to become the sole petroleum licensing authority for Northern Ireland it would be better able to assist the Organised Crime Task Force in combating the scourge of illicit fuel must also be questioned. Presently it has responsibility for enforcing the Carriage of Dangerous Goods by Road legislation. It is reasonable therefore to judge the soundness of the HSENI assertion on the basis of what it has achieved to date making use of its present powers. It is the case that this work has not been either high priority or high profile. More importantly how is an organization based in the centre of Belfast and proposing to deploy only seven compliance officers going to be able to gain intelligence as to illicit fuel. Councils are proactive within their localities and are thus much better placed to assist the Organised Crime Task Force as is the case presently.

- 4. The enforcement regime proposed by HSENI will increase business costs substantially. The proposed increases are as follows: 77% for the smallest sites, 68% for intermediate sites and 34% for the largest sites. It is telling that HSENI has chosen not to put a figure on the only benefit it has highlighted, namely the removal of periodic tank and pipework testing. Instead HSENI proposes to protect public safety and safeguard the environment by introducing a requirement for accurate record-keeping to detect any leaks from tanks or pipework. Accurate record-keeping is however not a new provision it is the standard required presently by district council licence.
- 5. Even with the cost of a petroleum licence under the new regime being calculated on a full-cost recovery basis the HSENI proposals do not represent value for money, as compliance costs would exceed income by some £300,000. District Councils would also be expected to bear the cost of staff no longer required to regulate petroleum.

*IT IS RECOMMENDED* that the proposals for the transfer of petroleum licensing functions from district councils to HSE NI be vigorously opposed.

#### \* Councillor Cavlan returned to the meeting at 8.12 pm.

The Director emphasized his concerns regarding these proposals when presenting his report and advised that the NI Chief Environmental Health Officers Group had also prepared a response to the Consultation Document which it would submit prior to the deadline of 12<sup>th</sup> January 2007. It was suggested by Members that Council write to MLA's, MP's and NILGA advising of the Council's concerns and inviting their support for the retention of petroleum licensing as a Council function.

#### \* Councillor Wilson left the meeting at 8.30 pm

It was proposed by Councillor Finlay, seconded by Councillor Cavlan and **AGREED:** 

to recommend to Council that representations rejecting the proposal by the Health & Safety Executive for Northern Ireland for the transfer of the petroleum licensing function from District Councils to HSENI be made and that the assistance of NILGA, MLA's and MP's be sought in opposing the HSENI proposals.

#### **ENVIRONMENTAL PROTECTION**

### 323.19 LOCAL AIR QUALITY MANAGEMENT (LAQM) – POLICY GUIDANCE ON SMOKE CONTROL AREAS

The Department of Environment, Environmental Policy Division has issued the above guidance LAQM.SCANI(06) under the Clean Air (NI) Order 1981 and the Environment (NI) Order 2002. The guidance is designed to assist District Councils in the preparation of Smoke Control Orders and in the Declaration of Smoke Control Areas. The guidance will be taken into consideration in the development of the Air Quality Action Plan currently being prepared to meet our obligations under the Ordinance of 2002. It replaces the Memorandum on Smoke Control areas issued by the former Ministry of Health and Social Services in 1964.

### 323.20 POLLUTION PREVENTION AND CONTROL REGULATIONS (NI) 2003 REGISTER OF PUBLIC INFORMATION

Environment & Heritage Service, on 20<sup>th</sup> November, furnished 'Annual Monitoring & Reporting' documents relating to Application No. P0038/04A (Yvonne McCrea) for inclusion in the Council's public register.

### 323.21 WASTE MANAGEMENT LICENSING REGULATIONS (NORTHERN IRELAND) 2003

#### APPLICATION FOR EXEMPTION:

#### Mr J Gilliland, 9 Leslie Hill, Ballymoney

The Department of Environment, Environment and Heritage Service, have advised by letter dated 23<sup>rd</sup> October 2006 that they have issued a Certificate of Registration for Exemption from Waste Management Licensing under the above Regulations.

The Exemption Certificate relates to the injection of sewage sludge. The activity must comply with the Nitrates Regulations when implemented. It does not permit the storage of sludge on the field. The certificate expires on the 17<sup>th</sup> October 2007.

During the discussion of this item, Councilor Cavlan referred to a previous application/exemption relating to use by Water Service of land at Slieveanorra and stated that it was very difficult getting a response from EHS. The Director advised that as he had also experienced this, it might now be best to raise any concerns via an MLA or the constituency MP.

### 323.22 WASTE MANAGEMENT LICENSING REGULATIONS (NORTHERN IRELAND) 2003

#### REGISTRATION FOR AGRICULTURAL EXEMPTION:

#### Mr R D Douthart, 12 Shelton Road, Armoy.

The above certificate issued by Environment and Heritage Service on the 23<sup>rd</sup> October 2006 refers to the following activities:

Burning waste plant in the open.

Spreading of dredgings and plant material cleared from inland waterways.

The Director commented on the figures provided for the Member's benefit. It was suggested by Councillor Robinson that further publicity might encourage residents of the Borough to become more vigilant as regard the use of both their blue and black bins and that use be made of the Council's own publication - Ballymoney Bulletin. Councilor McKay queried the need to produce information on the blue bins in relevant languages so as to assist ethnic minorities in understanding what may be recycled. The Director concurred with this view and confirmed that access to translation services was now available to Council

Councillor Finlay advised that when on the Isle of Man recently he took time to visit the incinerator, which in his view dealt very cost effectively with island waste. He advocated that this technology would be very beneficial and Members would be better informed were they also to visit the facility.

### 323.24 WASTE ELECTRICAL AND ELECTRONIC EQUIPMENT (WEEE) COLLECTION.

A WEEE collection facility at Knock Road Civic Amenity Site became operational on Monday 2<sup>nd</sup> October to facilitate the recycling of waste electrical and electronic equipment with the exclusion of fridges, freezers, washing machines etc.

During the first month of operation 4.09 tonnes of small WEEE (e.g. videos, stereos) and CRTs (e.g. televisions, monitors) was collected to be recycled by Avenue Recycling.

The Director advised that the service was being provided on a pilot basis and at cost to Council. Alderman Simpson asked if Council would allow people to remove items left by their owners for recycling. The Director advised that this would not be possible given that Council had to comply with its Duty of Care obligations. Alderman Campbell mentioned a charitable outlet in Coleraine which recycled electrical goods and undertook to pass details to the Director.

#### 323.25 LANDFILL DISPOSAL

It is pleasing to report that on 1<sup>st</sup> November the disposal of the Councils mixed municipal waste was successfully switched from Dargan Road Landfill to Bairds Brae Landfill at Cottonmount.

#### **FOOD CONTROL**

### 323.27 THE CURD CHEESE (RESTRICTION ON PLACING ON THE MARKET) REGULATIONS (NORTHERN IRELAND) 2006

The above Regulations made by the Department of Health, Social Services and Public Safety on the 18<sup>th</sup> October, came into operation on the same date. They implement commission decision 2006/694/EC prohibiting the placing on the market of curd cheese manufactured by Bowland Dairy Products Ltd. (UK PE 23).

### 323.28 THE RICE PRODUCTS (RESTRICTION ON FIRST PLACING ON THE MARKET) REGULATIONS (NORTHERN IRELAND) 2006

The above Regulations made by the Department of Health, Social Services and Public Safety came into effect on the 9<sup>th</sup> November. They implement Commission Decision 2006/601/EC on the import into the EU of an unauthorised genetically modified organism LL601 in rice products. The Regulations require importations of long grain rice to be subject to additional testing at the point entry to the EU, following discrepancies between results obtained between laboratories and the failure to agree a common testing protocol with the authorities in the USA.

### 323.29 THE PLASTIC MATERIAL & ARTICLES IN CONTACT WITH FOOD (NO 2) REGULATIONS (NORTHERN IRELAND) 2006

The above Regulations, which came into force on 19<sup>th</sup> November 2006, re-enact with certain changes the 2006 Regulations as well as providing for the execution and enforcement of Commission Directives 82/711/EEC, 85/572/EEC and 2002/72/EC.

### 323.30 FOOD STANDARDS AGENCY AUDIT OF FOOD LAW ENFORCEMENT SERVICE

Further to minute 322.17, the Food Standards Agency NI have requested that the audit be deferred until week commencing 11<sup>th</sup> December 2006.

#### 323.31 FOOD HYGIENE TRAINING

The Directorate delivered an Intermediate Food Hygiene Course between 5<sup>th</sup> September 2006 and 17<sup>th</sup> October 2006. A total of 4 candidates were successful in achieving the qualification.

#### **COMMUNITY SAFETY**

#### 323.33 APPOINTMENT OF COMMUNITY SAFETY CO-ORDINATOR (JOB SHARE)

Members will be pleased to learn that the above recruitment exercise has now been completed. Catherine Watson will commence duties on the 1<sup>st</sup> December

2006. Julie McGarry is due to return to the post on 4<sup>th</sup> December. The position has been vacant since the resignation of Colleen Macauley on the 31<sup>st</sup> July.

#### 343.34 KNIFE AMNESTY

A second knife amnesty was launched on the 20<sup>th</sup> November by the PSNI. The campaign will run for three weeks ending on the 12<sup>th</sup> December. As previously, secure bins have been provided at each of the civic amenity sites (Knock Road, Ballymoney and Crosstagherty) for disposal. The previous amnesty (May/June 2006) yielded 31 knives from within the Borough. It is hoped that the public awareness campaign will encourage others to dispose of such items safely during this period and reduce the incidence of knife related crimes thereafter.

#### **HEALTH ISSUES**

#### 343.35 NORTHERN IRELAND TO GO SMOKE-FREE ON 30<sup>TH</sup> APRIL 2007

The Health Minister, Paul Goggins announced on 16<sup>th</sup> November that Northern Ireland's smoke-free legislation will come into effect on 30<sup>th</sup> April 2007.

He stated – "Smoking is the single greatest cause of preventable illness and premature death in Northern Ireland, costing the health service around £44 million each year. This legislation will save lives. It will protect the public and employees from the harmful effects of tobacco smoke".

NI district councils will play a pivotal role in ensuring that the legislation achieves its objective of the cessation of smoking in enclosed public places and the Director advised members of this Council's proposals to provide businesses with any assistance necessary to enable compliance in the run up to the ban.

Following the presentation of this item, the Director advised that were Council to ensure that the ban would be effective in the Borough then there would be need both in the period prior to 30<sup>th</sup> April 2007 and in the six weeks to use staff to target relevant premises. Such need would mean that other work would have to be given a lower priority and he asked that Members note that this would be the case.

#### 343.36 CHILD MINDER OF THE YEAR AWARD

Councillor Robinson advised members that a Borough resident has been selected as 'Child Minder of the Year'. She requested that Council send a letter of congratulations.

#### 343.37 REVIEW OF PROJECTS FROM REVENUE RESERVES

At the request of Councillor Robinson, the Director agreed at the next meeting to provide an update regarding projects within the Committee remit which were to be funded out of reserves in the current year.

#### 343.38 SEWERAGE IN BAMFORD PARK

Councillor McKay drew attention to sewerage problems at Bamford Park. In the ensuing discussion mention was made of the continuing infrastructural deficit as regards new housing development within the village.

It was proposed by Councillor McKay, seconded by Councillor Cavlan and **AGREED:** 

that this Council write to Water Services seeking an urgent update on its infrastructure proposals as regards Rasharkin village.
