ENVIRONMENTAL SERVICES**333.1 MINUTES – MEETING NO 332 – 24TH SEPTEMBER 2007****Matters Arising****1.1 Proposed Meeting with DoE Minister (332.2.4)**

In answer to a question from Councillor McCamphill, the Director of Borough Services stated, as had previously been advised, that it was necessary to come up with a list of issues Members would like discussed with the Minister to be put to her prior to the arrangement of the proposed meeting. He indicated that he had written to all Members on 13th September and had not received any response. It was agreed that the request be re-issued to Members and on receipt of their responses, the Committee Chair and the Director would finalise the matter and then arrange the meeting with the Minister.

1.2 Adoption of Minutes

It was proposed by Councillor Finlay, seconded by Alderman Connolly and **AGREED:**

to recommend that the minutes of Meeting No 332 – 24th September 2007, as circulated, be confirmed as a correct record.

* **Councillor Patterson arrived at 7.32 pm.**

333.2 RECYCLING CENTRE AT DRUMAHEGLIS MARINA AND CARAVAN PARK

In consultation with the Head of Amenities ***IT IS RECOMMENDED*** that a recycling centre comprising banks for glass, cans, paper and plastic bottles be installed at Drumaheglis Marina and Caravan Park prior to the commencement of the 2008 season. In response to questions from Alderman Campbell, the Director confirmed that initially, this arrangement would be on a seasonal basis (17th March to end October 2008).

It was proposed by Councillor Stevenson, seconded by Alderman Campbell and **AGREED:**

to recommend that a recycling centre, as described above, be installed at Drumaheglis Marina and Caravan Park prior to the commencement of the 2008 season.

333.3 SHORT TERM RESIDUAL WASTE CONTRACT

Members are aware that Councils within both the NWRWVG and SWaMP have joined together in order to procure the necessary waste management technology required to deliver Waste Management Plan obligations and NILAS statutory targets from 2012.

It is evident from the Strategic Outline Case (SOC), brought also to the attention of Members that most NWRWVG and SWaMP Councils require a short term solution for residual waste in order to meet their respective NILAS statutory targets for 2009-2010 and the succeeding years. Certainly this is so, again as Members have been advised, the Ballymoney scenario.

Work has been undertaken with representatives for NWRWVG, SWaMP, PDSU and consultants RPS to consider the issue and also prepare contract documentation (within a very tight timescale) in order that the necessary service be tendered and hopefully secured.

The present scoping document for the service, together with the data for this authority was circulated to members.

IT IS RECOMMENDED that Council subscribe to the proposed short term contract for residual waste in the terms outlined.

In presenting his report the Director advised that work had been undertaken on the proposed Short Term Residual Waste Contract as a possible solution to the situation faced by the majority of Councils making up both NWRWMG and SWaMP in that the amount of waste to be landfilled in 2009-2010 and subsequently would exceed NILAS targets year on year. He pointed out that the purpose of the work undertaken was to test the marketplace and find out whether or not the private sector could deliver an interim solution and if so at what cost. The Director also pointed up the very exacting timeframe for the proposed project, as any solution was required by 1st April 2009.

Councillor Finlay stressed that it was necessary to consider not only this proposal but a range of solutions so that Council was in a position to pursue various strategies in order to ensure that it did meet its NILAS obligations. There was agreement on this. The Director advised that other measures Council could adopt were presently being researched and that he hoped to be in a position at the next meeting of the NILAS Working Group to bring a report .

It was proposed by Councillor Finlay, seconded by Councillor Stevenson and **AGREED:**

to recommend that Council subscribe to the proposed short term contract for residual waste in the terms outlined.

333.4 TIMBER TENDER

Work has been undertaken in conjunction with colleagues at SWaMP, NWRWM Group and their respective constituent councils in order to prepare tender documentation, compliant with both European and National procurement provisions for the following service –

The collection, transfer and recycling of timber within the North West Region Waste Management Group (NWRWMG) and the Southern Waste Management Partnership (SWaMP) regions.

IT IS RECOMMENDED that Council note and endorse this endeavour to secure a timber recycling service.

It was proposed by Councillor Finlay, seconded by Alderman Campbell and **AGREED:**

to recommend that Council note and endorse the endeavour to secure a timber recycling service.

333.5 NILAS WORKING GROUP

The minutes of meeting no. 2 of the NILAS Working Group, held on 11th October 2007, were circulated.

Councillor Robinson, on points of minute accuracy, advised that when she had drawn attention to the use of kerbie boxes it was to suggest that these be used to augment the Councils present collection system for separation of waste at each household and so improve waste recycling. She also clarified that it was now proposed to spend the Councils remaining Waste Management Grant on [1] the purchase and distribution of brown bins and [2] the purchase and installation of cardboard compactor units at its CA Sites.

5.1 Adoption of NILAS Working Group Minutes

It was proposed by Councillor Finlay, seconded by Councillor Stevenson and **AGREED:**

that the minutes of the NILAS Working Group on 11th October, as circulated, be confirmed as a correct record with the clarification as detailed above.

5.2 Brown Bins

The Director explained to Members that in order to secure delivery of the brown bins Council had agreed to purchase for distribution commencing mid-January it was necessary to place an order on 24th October. He advised that work was on-going to define where brown bins would be rolled out initially now that green waste was the primary target and that there was a considerable amount of work involved in finalizing routes, collection calendars, service literature service criteria, etc. He advised that when such work was more advanced a report would come before Committee.

It was proposed by Councillor Finlay, seconded by Councillor Stevenson and **AGREED:**

to recommend to Council that the order be placed for the purchase of 8,000 brown bins.

5.3 NILAS Working Group Meeting

It was agreed that the next meeting of the NILAS Working Group be held on Wednesday, 14th November at 3.30pm in Riada House.

Councillor Robinson restated her understanding of the remit of the NILAS Working Group, that its role was to identify potential solutions relating to the Councils obligation to meet its NILAS targets and to report these to Committee for further discussion. Members concurred.

ENVIRONMENTAL PROTECTION

333.6 TRAFFIC CONGESTION – NORTH ROAD

Ballymoney Borough Road Safety Committee has written on 1st October 2007 to convey its concerns regarding traffic congestion at North Road. That Committee has asked "if it would be possible for you (Council) to carry out air quality

monitoring in the area where the congestion is occurring at peak times when traffic is arriving and leaving the schools”.

The Director advised that it would be possible for such monitoring to be undertaken deploying equipment specifically hired for the purpose to determine NO_x levels. The cost would be between £1,500 and £3,500 per month depending on the type of equipment deployed and monitoring over a 3-month period is recommended. No budgetary provision has been made for this type of air quality monitoring.

As the only reliable method of determining NO_x levels at the location highlighted ***IT IS RECOMMENDED*** that monitoring as sought by the local Road Safety Committee be undertaken.

Councillor McCamphill asked what could Council do were it to monitor air quality as requested. The Director advised that as Council would have definitive data as to whether or not there was an air quality issue at the particular location it would be well placed to make representations to Road Service and others as to the need to undertake remedial measures. Alderman Campbell intimated that he thought that the Council had suitable equipment. The Director advised that the equipment being referred to was suitable only for indoor air quality monitoring and that is why quotations for appropriate equipment had been sought. As no budgetary provision for this type of monitoring had been made in the current financial year, Councillor Finlay expressed the view that the matter be deferred due to lack of available funds at this time.

It was proposed by Councillor Finlay, seconded by Councillor Stevenson and **AGREED:**

to recommend that the matter be deferred for consideration in the next Rates Estimates process.

DOG CONTROL

333.14 DOGS (NORTHERN IRELAND) ORDER 1983 ALLEGED ATTACK BY DOGS ON PERSONS

On 21st August 2007, the Directorate received a complaint regarding an alleged attack by dogs involving a six year old girl who had been severely bitten by two Rottweilers.

The attack had initially been witnessed by two other children who raised the alarm. The child's stepfather and mother also witnessed the continued attack as they ran from the house to their daughter's aid. The child was taken to the Accident and Emergency Department of the Causeway Hospital, Coleraine, where she was treated and subsequently transferred later that day to the Ulster Hospital, Dundonald.

The two dogs involved in the alleged incident were destroyed immediately after the incident by the owner. A third dog although not involved in the alleged attack was taken by the owner and humanely put to sleep by a local vet.

The owner of the dogs has been interviewed regarding the matter. Statements have been recorded from all witnesses involved.

It subsequently was evident that the child's mother was also injured by the dogs whilst trying to protect her little girl from further attack.

Medical evidence regarding the child has been received from the medical records department, Causeway Hospital, which gives a diagnosis of "multiple dog bites". The child had to undergo plastic surgery on 22nd August 2007, at the Ulster Hospital, Dundonald.

Medical evidence regarding the child's mother has been received from the medical records department, Causeway Hospital which gives a diagnosis of grazing and an associated puncture wound likely to be a dog bite to the posterior aspect of her chest wall.

The Borough Council's Solicitor has been consulted and has opined that there is a prima facie case to answer in this instance.

On this basis, ***IT IS RECOMMENDED*** that legal proceedings be instigated.

It was proposed by Councillor McCamphill, seconded by Councillor McKay and
AGREED:

to recommend that Council instigate legal proceedings.

333.16 ERECTION OF STREET NAMEPLATES IN A LANGUAGE OTHER THAN ENGLISH

This matter was deferred from the previous Committee meeting. In order to assist Members the report made to Committee and considered at its meeting held on 28th August 2007 is reproduced –

“Occupiers of premises have initiated procedures for the erection of a street nameplate in a street in a language other than English in respect of the three streets within the Borough. Correspondence, together with petitions, were received in April 2007 requesting that bi-lingual signage be provided at Bellaghy Park, Dunloy; Glebe Park, Rasharkin; and Scally Park, Loughgiel.

Following the completion of necessary preliminaries the occupiers of premises were written to on 28th June 2007 and asked to complete and return (no later than Friday, 27th July 2007) a survey form.

The number of valid responses in each case is as follows:-

<u>Street</u>	<u>valid responses</u>
Bellaghy Park, Dunloy.	17
Glebe Park, Rasharkin.	17
Scally Park, Loughgiel.	35

As regards each location, it is the case that two thirds or more of respondents to the survey conducted, support the erection of a sign in a language (Irish) other than English.

The format of the signage which may be erected is reproduced at Appendix 2 to this report.

In accordance with the Council’s Policy – Naming of Streets and Numbering of Properties ***IT IS RECOMMENDED*** that Committee consider the applications and make a recommendation to Council.”

It was proposed by Councillor McCamphill, seconded by Councillor McKay

to recommend to Council that it implement its policy for the erection of street nameplates in a language other than English as regards the three locations detailed above.

The Mayor indicated that having looked at the responses to the questionnaire issued by Council to ascertain the view of residents he believed that there was no great appetite for bilingual signage at the locations under consideration and that the issue seemed to be politically motivated. Speaking on behalf of his party grouping he stated that whilst not being in favour, it was nonetheless necessary to implement Council policy as required by law.

Councillor Patterson requested that her opposition be recorded.

The proposal was put to the vote with three abstentions, two members voting against the proposal and two members voting in favour.

The Chair not having used her casting vote, the motion was declared not carried.

333.17 NAMING OF HOUSING DEVELOPMENT

**5 Dwellings at Craigs Road, Drumack, Rasharkin,
for Scott Homes Ltd, 80 Ballycraigagh Road, Clough, Ballymena**

The developers have written by letter dated 23/06/2007 requesting that Council name the above new housing development.

The names suggested by the developer, in order of preference, are

1. "Drumack Valley".
2. "Drumack Hollow".

Both names are in accordance with the general policy that street names should have some connection with the local area in which they are located (the development is within the townland of Drumack).

Although the development is on the periphery of the Bann Valley, it occupies a natural hollow on the south-western side of the Craigs Road, and for this reason it is felt that the second preference name of "Drumack Hollow" is the more suitable choice. ***IT IS RECOMMENDED***, therefore, that Council approve the name "Drumack Hollow" for the overall development.

It was proposed by Councillor Stevenson, seconded by Councillor McCamphill and **AGREED:**

to recommend that Council approve the name "Drumack Hollow" for the development.

FOOD CONTROL

333.19 THE NATURAL MINERAL WATER, SPRINGWATER AND BOTTLED DRINKING WATER REGULATIONS (NORTHERN IRELAND) 2007

These consolidating Regulations, which will come into operation on 31st October 2007, bring together into a single set of Regulations three existing statutory rules which implement all current European legislation relating to natural mineral water, spring water and bottled drinking water.

333.20 THE PLASTIC MATERIALS AND ARTICLES IN CONTACT WITH FOOD (LID GASKETS) REGULATIONS (NORTHERN IRELAND) 2007

The above Regulations, which will come into effect on 5th November 2007, provide for the execution and enforcement of Commission Regulation (EC) No. 372/2007 laying down transitional migration limits for plasticisers in gaskets in lids intended to come into contact with foods.

333.21 THE FOOD FOR PARTICULAR NUTRITIONAL USES (MISCELLANEOUS AMENDMENTS) REGULATIONS (NORTHERN IRELAND) 2007

The above Regulations, which come into operation on 15th October, amend various statutory instruments in response to the UK's obligations to implement EU law.

333.22 FOOT AND MOUTH DISEASE (FMD)

Following confirmation of a second outbreak of FMD in England in September the European Commission has banned the intra-community trade in meat products derived from bovines, ovines, caprines and porcines and other biungulates, originating from Great Britain (Commission Decision 2007/554/EC as amended refers). However, products made from most meat produced in Northern Ireland is eligible for intra-community trade but must be accompanied by an official certificate when dispatched.

1 certificate has currently been issued since the second outbreak to McKeown Fine Foods Ltd, 296 Townhill Rd, Rasharkin to allow trade into other member states.

DOG CONTROL

333.23 The USPCA has written expressing the Society's gratitude to two of the Directorate's staff in respect of an operation mounted by the USPCA supported by the PSNI to seize illegal dogs on 22nd September 2007. The operation was successful.

The letter states: "This operation was carried out with very little advance notice and we were very impressed with how obliging your staff were with regards to attending the scene and support for the USPCA. We were conscious at all times it was a Saturday afternoon and that this was an intrusion into their private time."

Members requested the Director convey their appreciation to the staff involved.

COMMUNITY SAFETY

333.24 SAFER BONFIRE COMPETITION

The 2007 October Safer Bonfire Competition has been launched. Once again the competition aims to encourage due care and consideration in the organising of these events by offering a prize for the safest sites within the Borough. Full guidance and competition rules are available on the council's website and from the Community Safety Partnership.

333.25 CAUSEWAY VIPS YOUR KEY TO SECURITY

The 'Your Key to Security' project, which aims to reduce crime and fear of crime in the Ballymoney, Coleraine and Moyle areas, was launched in the Royal Court Hotel on Monday 15th October 2007. Causeway VIP's highly successful 'Your Key to Security' scheme is being extended to offer priority help on home security to vulnerable people, including older people, victims of domestic violence, people with disabilities and victims of crime. The scheme will provide information, support, a free security assessment and equipment depending on each individual case.

333.26 FIREWORKS SAFETY AWARENESS CAMPAIGN

The launch of the fireworks public safety awareness campaign took place at the NIFRS Training centre on Monday 8th October 2007. A local campaign aimed at local secondary schools will take place in the weeks prior to Halloween in partnership with the PSNI, Ballymoney Home Accident Prevention and Ballymoney Community Safety Partnership.
