Councillor Robinson drew members' attention to the welcome reduction in mixed residual waste, which has fallen overall this year by almost 11%. Reduction in blue bin waste was discussed the cause of which may be attributable to the current economic climate resulting in less packaged goods being purchased. Brown bin recycling continues to be monitored and will be reviewed on the basis of the information gathered during the winter months to enable future planning. Other issues discussed included

- Position of Ballymoney in the league table of Councils relating to recycling
- Removal of wood from CA sites
- Monitoring for increased use of CA sites at weekends
- Monitoring for use of CA sites by businesses

### **FOOD CONTROL**

#### **348.17 NEW LEGISLATION - THE PLASTIC MATERIALS AND ARTICLES IN CONTACT WITH FOOD REGULATIONS (NORTHERN IRELAND) 2009**

The above Regulations, which provide for the implementation in Northern Ireland of Commission Directive 2008/39/EC, came into operation on 13<sup>th</sup> March 2009.

Directive 2008/39/EC makes several important amendments to the 2002 Directive:

- It lays down the dates by which the list of additives that may be used in the manufacture of food contact plastics will be closed and makes interim arrangements for those additives that were the subject of an application for authorisation by the deadline of December 2006;
- It sets a date of 31<sup>st</sup> December 2009 up to which additives not on the positive list may continue to be used. This period will enable the European Food Safety Authority (EFSA) to obtain any additional information it might need for its risk assessment of the additives in question;
- It prohibits the use of additives not on the Community list of additives (the positive list), including the provisional list, from 1<sup>st</sup> January 2010;
- It prohibits as from 7<sup>th</sup> March 2010 the manufacture and importation into the Community of food contact plastic materials and articles that do not comply with the Directive, as amended. In effect this creates a phase-out period for substances that have either been removed from the Community list, or have not been adopted on to it;
- It routinely updates the lists of authorised substances, taking into account the published opinions of EFSA; and
- It permits the trade in and use of plastic material and articles intended to come into contact with food and complying with the Directive, as amended, from 7<sup>th</sup> March 2009.

## HEALTH & SAFETY

### **348.18 CONSULTATION DOCUMENT: PROPOSALS FOR CHEMICALS (HAZARD INFORMATION AND PACKAGING FOR SUPPLY) REGULATIONS (NORTHERN IRELAND) 2009**

HSENI has advised that it has issued the above consultation. The main aims of the proposals are to update the current Chemicals (Hazard Information and Packaging for Supply) Regulations (NI) 2002 as a consequence of the adoption and entry into force of the European Regulation (Regulation EC No. 1272/2008) on the Classification, Labelling and Packaging of substances and Mixtures – CLP Regulation. The deadline for comments is noon, Friday 17<sup>th</sup> April 2009.

## FUEL POVERTY

**348.19** The Northern Investing for Health Partnership's Fuel Poverty Steering Group has won the prize for most Innovative Fuel Poverty Scheme in the Housing Executive's Home Energy Awards 2009. It was chosen for its ability to target those facing fuel poverty across the Northern Health & Social Services Board area. Through a number of partnerships, including that with Ballymoney Borough Council, the

initiative has referred over 1,600 households to fuel poverty grant schemes, trained over 400 people in energy efficiency and supported the establishment of seven oil stamp savings schemes.

Ballymoney Borough Council is represented on the NIFHP Fuel Poverty Steering Group by its Director of Borough Services and has worked closely with the Partnership to tackle fuel poverty and encourage energy efficiency locally. Council hosts both the Fuel Poverty Strategy Co-Ordinator and the Causeway Energy Efficiency Adviser. The award submission highlighted local initiatives such as the promotion of fuel poverty grant schemes, the Ballymoney Oil Stamp Saving Scheme and the establishment of the Ballymoney Warmer Homes Group.

The Award was presented by the Minister for Social Development, Margaret Ritchie, to Jacqui Frazer, Fuel Poverty Strategy Co-Ordinator at a ceremony in the Stormont Hotel, Belfast in February.

Councillor Robinson congratulated the Fuel Poverty Strategy Co-ordinator on her award and thanked the officers and staff in the Department for their work, Ballymoney having led the way in initiatives, which have been replicated throughout the Province.

## **HEALTH & WELLBEING**

### **348.20 NO SMOKING DAY 11<sup>TH</sup> MARCH**

This years National No Smoking Day theme was "Up In Smoke". It was designed to get the message across about the cost involved with smoking especially in the current economic climate as well as the health inequalities, and that it is financial circumstances that is likely to give smokers the final nudge to quit.

A poster competition was held between the secondary schools in the Borough; Our Lady Of Lourdes, Dalriada and Ballymoney High School. The aim of the poster was to get the pupils thinking about how money could be better spent e.g. TVs, holidays or magazines, than on cigarettes. An excellent response was received and all three schools participated.

There was 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> within each school and an overall 1<sup>st</sup> prize, which went to Our Lady Of Lourdes. Basil Knipe Electrics sponsored three MP3 Players for winners and an audio system for overall winner; with the Directorate providing 2<sup>nd</sup> and 3<sup>rd</sup> place prizes.

Campaign posters were posted on town map sites; a leaflet drop and freebies handed out to the community association groups and information displayed at Joey Dunlop Leisure Centre, as part of the Directorate's promotion of the event.
