351.1 ELECTION OF CHAIR

At the request of the Deputy Director, the Mayor invited proposals for the position of Chair of the Committee.

MATTERS FOR CONSIDERATION

ENVIRONMENTAL SERVICES

351.4 NWRWMG MIXED DRY RECYCLATES CONTRACT EXTENSION

At the meeting of the North West Region Waste Management Group Sub-Committee held on Wednesday the 6th May 2009 in Strabane District Council offices, the committee confirmed its position regarding the extension of the Mixed Dry Recyclables Contract with Glassdon Waste.

Under the terms of the contract the Councils, on behalf of the NWRWMG, have the option to extend the contract for a period of two years followed by two further annual extensions up to a maximum of nine years in total.

The Officers group met with the contractor to discuss the potential operation of the contract going forward.

Glassdon proposed an increase in the range of materials it could accept together with a reduction of three pounds per tonne in the cost and has now confirmed a timetable for receipt of these materials.

In light of the satisfactory performance of the contract to date, together with the arrangements moving forward, the NWRWMG Sub-Committee has agreed to recommend to member councils that the option to extend should be exercised for a period of a further two years after which it will consider its position again.

IT IS RECOMMENDED that Ballymoney Borough Council, in accordance with the recommendation made by the North West Region Waste Management Group Sub-Committee, agree to extend the existing Mixed Dry Recyclates Contract for a further two-year period.

At the request of Councillor Finlay, the Chair clarified the timescales involved in the collection of additional materials, commencing in June-September 2009. Councillor Finlay enquired as to the amount of money that would be saved with respect to the reduction in cost per tonne for the collection of such waste. The Deputy Director of Borough Services undertook to provide this information. The

Chair responded to Councillor Kennedy's question relating to value for money in extending the contract and incineration technology. She provided information on the technologies considered by the NWRWMG. She further advised that a copy of the Outline Business Case submitted and agreed by the NWRWMG is available to all members on request.

It was proposed by Alderman Cousley, seconded by Councillor Cavlan and **AGREED**:

to recommend that Council, in accordance with the recommendation made by the North West Region Waste Management Group Sub-Committee, agree to extend the existing Mixed Dry Recyclates Contract for a further two year period.

FOOD CONTROL

351.5 ENVIRONMENTAL HEALTH OFFICER TRAINING

The Department's District Environmental Health Officer has applied for assistance to undertake an Advanced Professional Certificate in Environmental Health Food Law Enforcement. This course has been designed by CAFRE at Loughry College in partnership with Northern Ireland Food Liaison Group. Successful completion of this course will lead to a BTEC accredited level 7 award. It runs from September 2009 – December 2009 with time off from duties 1 day per week for 15 weeks. The cost is approximately £500, which would be met from the current service budget.

IT IS RECOMMENDED that Council approves the above officer training.

The Deputy Director of Borough Services advised members that the duties of the post holder whilst attending studies would be covered by existing staff resources.

NAMING OF HOUSING DEVELOPMENT

The developers have written by letter dated 8/06/2009 requesting that Council name the above new housing development.

The name suggested by the developer is "Greenshields View".

The vista from the development is to some extent over the townland of *Greenshields Lower*, looking towards the small *Greenshields River* (a tributary of the Ballymoney River). A lane opposite the development (on the northern side of the Kilraughts Road) is known locally as *Greenshields Lane*.

The proposed name would appear to be in accordance with Council's Street Naming Policy which states that street names should have some connection with the local area in which they are located. *IT IS RECOMMENDED* therefore that Council approve the name "**Greenshields View**" for the development.

351.14 ERECTION OF STREET NAMEPLATES IN A LANGUAGE OTHER THAN ENGLISH

Occupiers of premises have initiated procedures for the erection of a street nameplate in a street in a language other than English in respect of two streets within the Borough. Correspondence, together with petitions, were received in November 2007 requesting that bi-lingual signage be provided at Carnfinton and Rhencullen Park.

Following the completion of necessary preliminaries the occupiers of premises were written to on 14th May 2009 and asked to complete and return (no later than Tuesday 16th June 2009) a survey form.

The number of valid responses in each case is as follows:-

351.17 GREEN FLAG AWARD

St Brigid's Primary School, Ballymoney is the most recent recipient of a Green Flag, through the Eco Schools Programme. The Green Flag, the highest honour in the scheme, acknowledged the tremendous effort by pupils and staff, across areas

including waste and global perspectives. The assessors praised the school saying the project represented one of the most imaginative applications of IT ever seen in Northern Ireland to Eco Schools. St Brigid's joins Ballymoney Nursery School in being awarded a Green Flag in recent weeks. Both schools were actively supported by the Recycling and Education Officer and further developments are planned for next year, with different schools involved.

The Chair recommended the work of the schools involved and congratulated the Recycling and Education Officer for the work he has undertaken with the schools.

ENVIRONMENTAL PROTECTION

351.18 FLOURINATED GREENHOUSE GASES REGULATIONS (NORTHERN IRELAND) 2009

The above Regulations, which came into operation on 12th May 2009, give effect to Regulation (EC) No. 842/2006 together with ten others on certain fluorinated greenhouse gases.

Members are asked to note that the Regulations specify that NI district councils must enforce these Regulations.

351.19 THE WASTE MANAGEMENT LICENSING REGULATIONS (NI) 2003: APPLICATIONS FOR EXEMPTION.

NIEA has issued to Council a Certificate of Registration for Exemption from Waste Management Licensing under the Waste Management Licensing Regulations (NI) 2003 in respect of its 10 no. Community Recycling Centres. The exemption certificate ref. WMEX 05/27 pertains to the period 10th April 2009 to 9th April 2012.

An exemption certificate ref. WMEX 05/08 has also been issued to Compass Advocacy Network t/a Can Can Recycling in respect of activities at the Community Recycling Centres. This exemption certificate pertains to the period 8th April 2009 to 7th April 2012.

351.20 ENERGY PERFORMANCE OF BUILDINGS

As Members are aware, DFP has sought the involvement of NI District Councils in undertaking enforcement functions in respect of the provision of the Energy Performance of Buildings (Certificates and Inspections) Regulations (NI) 2008. Council has agreed to the proposed transfer of enforcement functions from DFP to District Councils in principle.

What is now being put forward by DFP and the Building Control Service is that in 2009-2010 a one year pilot study be used to determine the resource implications for Councils. The Councils Head of Building Control has intimated that the service here is content with the proposed pilot being undertaken.

FOOD CONTROL

351.21 FOOD COMPLAINT - DEAD MOUSE IN HYNDMAN'S MALT LOAF

On 31st December 2007 a food complaint was received in relation to a dead mouse in a loaf of bread. Following an investigation the matter was reported to Council on the 2nd June 2008 (Council minute 881.9.93 refers) with the recommendation that the manufacturer be prosecuted for producing unfit food.

On Friday 5th June 2009 at North Antrim Magistrates Court D Hyndman & Sons (Bakery) Ltd pleaded guilty to putting on the market, for sale, unfit food, thereby breaching food legislation.

When determining the defendants fine the Magistrate took into account public concern, the steps the company are taking regarding hygiene and the fact the defendant had no previous convictions and fined the company £1000 plus costs.

351.22 THE CONTAMINANTS IN FOOD REGULATIONS (NI) 2009

The DHSSPS made the above regulations on the 28th May with an operative date of 1st July 2009. The regulations revoke and re-enact with changes, the 2007 regulations of the same title. Specifically they implement Commission Regulation EC No. 565/2008, 629/2008 and 124/2009. Separate legislation for England, Wales and Scotland has been made in parallel.

HEALTH & SAFETY

351.23 SAFETY OF SPORTS GROUNDS (NI) ORDER 2006

Correspondence from Department of Culture, Arts and Leisure has been received dated 22nd and 26th May with respect to the above. In accordance with the above Order, the Department is proposing to designate, by order sports grounds being able to accommodate more than 5,000 spectators. Two facilities within the Borough Council area have been determined to fall within this definition as determined by Sport Northern Ireland (SNI) –

Loughguile GAC, Loughguile. Riada Stadium, Ballymoney.

In accordance with Article 19(1)(b) of the Order the Department also proposes to prescribe by regulation the fees to be charged by district councils in respect of applications for the issue amendment, replacement and transfer of safety certificates.

In addition, in accordance with Article 19(1)(2) of the Order, the regulations will prescribe the time within which appeals under articles 8, 10 & 17 may be brought (see Appendix 4, page 14 to this report).

Comments were invited to be submitted by 8th June 2009.

COMMUNITY SAFETY

351.25 SUMMER SPLASH

Ballymoney Community Safety Partnership has secured £6,000 from the Northern Ireland Office Community Safety Unit to undertake the Summer Splash initiative again this year. The initiative aims to reduce anti-social behaviour by providing activities to divert young people away from acting in an anti-social manner during July and August and offer them a more positive and constructive way of using their time. All community groups have been offered the opportunity to participate in this initiative and avail of a range of outdoor pursuits and creative arts workshops targeted at the 13-18 year old age group.

The Deputy Director of Borough Services advised that 10 groups have signed up to take part to date.

351.26 MAKIN' SENSE

Following the success of last years Makin' Sense project Ballymoney Community Safety Partnership have secured funding to undertake the project again this year. We have booked Solomon Theatre Company to undertake a similar piece of drama and workshops to that of 'Last Orders', which was used last year.

Once again the programme will consist of one piece of drama, combining live theatre performance and process drama activities, focusing on risk, enabling young audiences to see the unpleasant and dangerous consequences arising from risk-taking behaviour. This will then be followed by a number of tailored workshops exploring the issues in more depth. The project will take place from the 2nd to the 6th November 2009.

351.27 NEIGHBOURHOOD WATCH

Wallace Park and Church Meadows in Rasharkin have been accredited for the Neighbourhood Watch Schemes. Signage has been erected in these areas to indicate their participation in the scheme.

351.28 SAFER BONFIRE COMPETITION

The subgroup launched their annual safer bonfire competition on Wednesday 3rd June. The aim of the competition is to encourage organisers of traditional bonfires (those which have been in existence for the eight years or longer) in the Borough to think of both safety and the environment when organising the event. A competition pack is available from Borough Services or can be downloaded via the council website.

HEALTH & HOUSING

351.30 NORTHERN IRELAND HOUSES IN MULTIPLE OCCUPATION STRATEGY 2009

On 8th June 2009, the Directorate received a copy of the NIHE's Northern Ireland Houses in Multiple Occupation 2009. The Housing Executive states that its main concern in relation to HMOs remains the protection of the health, safety and wellbeing of the occupants, and that the accelerated programme for the implementation of HMO registration throughout Northern Ireland reflects this.

351.31 AVAILABILITY OF LANDLORD RENOVATION GRANTS FOLLOWING THE SERVICE OF A NOTICE OF UNFITNESS

The NIHE have recently issued a press release explaining the allocation of 2009-10 funding provided by Government. The Grant allocation budget permits them to process mandatory disabled facilities and repair grants only. (The latter would be eligible to owner/occupiers/landlords on issue of a Public Health Notice). The NIHE will be unable to continue to process non-mandatory renovation,

replacement, home repair assistance and HMO grants, prioritising its resources instead towards the provision of new social housing and returning vacant Housing Executive homes back into use.

351.32 NORTHERN IRELAND HMO STATUTORY REGISTRATION SCHEME

The NIHE have provided a revised HMO statutory registration scheme (amended September 2008). Amendments have been made to previous registration schemes (Belfast and Bangor areas). The amendments are set out in the appendices along with registration dates. An application to register must be made by the date set out in the appendix. After a registration application has been submitted to NIHE an inspection will be carried out by HMO office staff and advice given to ensure compliance. The registration date for those in Ballymoney Council area is 1st November 2010.

BUILDING CONTROL

351.33 USE OF TOWNLAND NAMES
