376.2 MACMILLAN CANCER SUPPORT

Correspondence has been received from Macmillan Cancer Support seeking the assistance of all NI district Council's in raising awareness of the organisation in its centenary year 2011. The idea of helping Macmillan raise its profile in local communities by Council "re-designing its flower beds" has been mentioned.

376.3 SPRINGWELL CUP: PRIMARY SCHOOLS CROSS-COUNTRY

376.5 LAND AT RASHARKIN CEMETERY

Enquiries have been made as to whether or not Council would let its additional land at Rasharkin Cemetery. Given that the land, circa 2.8 acres, is surplus to requirements for the foreseeable future, it could be let for grazing, other purposes, for say 4 to 5 years, with the leasee being responsible for fencing and keeping in good heart, etc.

As it would not be appropriate to permit access from the county road through the cemetery, the land ought to be offered to its three adjoining land owners by inviting sealed bids.

IT IS RECOMMENDED that Council offer the land surplus to its present and foreseeable requirements at Rasharkin Cemetery in accordance with the Director's advice set out above.

376.6 TRANSLINK ULSTER IN BLOOM: 2010 COMPETITION

As members may be aware from media coverage, Ballymoney achieved a very credible joint third placing in the `Town' category of this year's Translink Ulster in Bloom Competition. The announcement of winners was made at Lissanoure Castle, Loughgiel on 2nd September. As was the case in 2009, Coleraine won the `Town' category and this year Dungannon came second and Banbridge and Ballymoney joint third. At the announcement of winners it was satisfying to note that three slides from Ballymoney were used by the judges to illustrate innovative and good practice.

Councillor Robinson commented on the very pleasing flower arrangements during the summer season and extended her thanks to all involved with this. Councillor Finlay concurred with Councillor Robinson's comments. In thanking the members for the sentiments expressed, the Director intimated that presently work was on-going to identify modest ways in which some improvements might be made to Ballymoney town bearing in mind next year's competition and advised that an order would shortly be being placed for the necessary plants. It was proposed by Councillor Robinson, seconded by Councillor Finlay and **AGREED:**

to recommend that Council hold a reception for employees involved with the Translink Ulster in Bloom Competition, as a mark of appreciation for their hard work and commitment made during the season and in attaining joint third prize in the 'Town' category.

376.7 NATIONAL TRIALS DAY 2010

National Trails Day is an all Ireland event celebrating the wonderful variety of countryside trails to be found throughout Ireland, for walking, cycling, horseriding, canoeing and many other activities. The main aim of the day is to encourage people of all ages and backgrounds to get outdoors. This year the event will be held on Sunday 3rd October and Ballymoney will be hosting one of the walking activities with a nature ramble in Riverside Park at 11am. Participants will experience the abundance of natural attributes which can be found within a small urban park setting and its importance both for wildlife and plant life. The Countryside Access and Activities Network (CAAN) is organising and marketing National Trails Day with the support of financial partners DCAL, NIEA, Waterways Ireland and Sport NI. 376.8 DERVOCK COMMUNITY ASSOCIATION CORRESPONDENCE

Arising from a meeting with Councillor Storey and others to discuss Dervock's 2012 Olympic Games initiative, correspondence has been received from Dervock Community Association. In essence Council is asked to indicate what is happening from its perspective concerning the innovative Dervock community facility – "Can we ask for your perspective on where we might be by the time of the Olympics in terms of new changing rooms and perhaps including some aspect of our modular plan for a much needed village sports facility?"

A discussion ensued, during which the Director was advised as to overtures made on behalf of the local football club as regards training facilities and lighting for same. Councillor Finlay requested that the Director bring a report back to Committee at a future date in respect of the issues raised including cost projections.

376.9 SAFETY OF SPORTS GROUNDS: RIADA STADIUM

As members have previously been advised DCAL has designated the Council's Riada Stadium as a venue to which the Safety of Sports Grounds (NI) Order 2006 and associated guidance applies. Consequently Council, in accordance with its statutory obligations, must issue a General Safety Certificate for its designated venue. This process is well advanced and the draft General Safety Certificate for Riada Stadium, it is anticipated, will be brought before the Council's Health & Environmental Services Committee, to be held on 28th September 2010.

During the safety certification process undertaken in respect of Riada Stadium, certain issues have come to light which, if not rectified, will limit the number of spectators permitted at the venue.

It is also the case that having become aware of Sport NI's Stadia Safety Programme – Urgent Works funding scheme, 2 no. applications were made on behalf of Council by the deadline (27.08.2010) – an infrastructure application and a safety equipment application. In conjunction with the former funding application, as members are aware, a planning application, which has been streamlined, has also been made to Planning Service. Were Council to be successful as regards the funding applications made to Sport NI, it could then undertake necessary work at Riada Stadium in order to bring the venue better in line with the statutory guidance relating to spectator safety.

376.10 ALTNARICHARD PICNIC AREA

Work has been undertaken over the summer, which is on-going, with the Office of the Chief Executive, to draw down funding under the INTERREG Causeway Connections Project. As the only potential Council scheme which fits the project criteria, assistance (on a 100% basis) is being sought to carry out essential work at this location as part of improving the Borough's walk product and infrastructure.

Total visitors since 9 May 2009 [16 months] when we re-opened after the refit is: **23,181**. This gives an average per month of **1450** visitors.

Comments from Jim Redman MBE, six times World Champion motorcycle road racer, who visited the museum while here for the 'Roon tha Toon' event, 2 August 2010:

"I think it is fantastic the way that Joey and all the other riders have been given such recognition by the whole town. Most places would have let Joey just fade away. Congratulations to all those concerned."

The exhibition has moved to Down County Museum from 17 September – 14 November. In Downpatrick, the display will include the original NW200 trophies, a collection of trophies from the Dromara Destroyers, leathers & helmets from the Dromara Destroyers and three motorcycles. Two of the motorcycles belong to a local collector, Ivor Skelton, a long time supporter of Ballymoney Museum.

Cycling Past

The current exhibition 'Cycling Past' was launched by the Mayor on 9th September and runs to 30th October. It is proving extremely popular and in recent days visitors have arrived from across NI specifically to see the display. Later this month a community arts project, funded by the Good Relations Programme, will conclude with the unveiling of a sculpture in the museum made from recycled bicycle parts and created by pupils from Ballymoney Model PS and St Joseph's PS Dunloy.

The Route Back Home

The Route Back Home family history festival (1 & 2 October) has attracted people from the USA, Ireland, England & Scotland, in addition to local enthusiasts. Representatives from the Ulster Historical Foundation, Public Record Office NI, Centre for Migration Studies, Libraries NI, Queen's University and the North of Ireland Family History Society will be taking part. In total, approximately 40 delegates are expected, including places made available to the members of the local community groups through Good Relations funding.

Millions of children in polioendemic countries know that a freshly marked purple finger means freedom from the disease, each purple crocus is a symbol of helping one child become free from polio forever.

to recommend that Council grant The Rotary Club of Ballymoney permission to plant 5,000 purple crocus bulbs outside The Conservatory Restaurant at the Joey Dunlop Leisure Centre.
