Item No 1 - D/2010/0304/F - Refusal

Proposed authorised treatment facility for depolluting end of life vehicles plus retention of vehicle dismantling yard at 29A Garryduff Road, Ballymoney BT53 7BS for Mr A McMullan.

It was AGREED: That an office meeting be held (Councillor Finlay).

The Planning Officer advised that traffic survey had been carried out and improvements made on widening of laneways but visability splays have not been improved. Planning Service HQ will be invited to attend the office meeting.

Item No 2 - D/2011/0042/F - Refusal

Proposed new dwelling and detached garage to supersede previously approved D/2008/0497/RM at 85m NW of 31 Loughabin Road, Ballymoney for Mr D McMillan.

It was AGREED: That an office meeting be held (Councillor Finlay).

Councillor Finlay expressed disappointment at the decision to refuse the application as renewal had been submitted prior to expiry of the previous application.

Item No 4 - D/2011/0054/F - Approval

Single wind turbine with a hub height of 30 m at 283m SE of 99 Ballyveely Road, Loughguile for S Thompson.

Objection letters (4)

Noise, impact on value of property and visual impact.

Proposal scaled down to 30m. Department consulted with Department of Environmental Health who offered no objections. At the request of Councillor Storey, the Planning Officer clarified the Department's position on the size and scale of wind turbines explaining that each application is considered on its own merits relating to the location and surroundings of the proposal.

Item No 5 – D/2011/0066/F – Approval

Proposed new dwelling previously approved under D/2008/0194 at 94 Kirk Road, Ballymoney for Mr & Mrs Adams.

Objection Letters (1) Access – joint access arrangements now agreed.

The Planning Officer advised that the proposal offers an infill opportunity and is now able to be approved.

Item No 6 - D/2011/0132/F - Refusal

Proposed wind turbine (37m hub height) at 755m West of 290 Frosses Road, Cloughmills for Mr D Logan.

item No 9 - D/2011/0158/0 - Refusal

Dwelling on the farm and detached garage at 30m West of 217 Corkey Road, Cloughmills for Mr P McAleese.
