### 375.1 MINUTES - Meeting No 374 - 25th October 2011

It was proposed by Alderman Campbell, seconded by Alderman Cousley and **AGREED:** 

to recommend that the minutes of Meeting Number 374 – 25<sup>th</sup> October 2011, as circulated, be confirmed as a correct record.

### **375.2 VIDEO** – The Future to Resource Management

The Chair introduced a short video "The Future of Waste Resource Management" which highlighted the various initiatives by the North West Region Waste Management Group.

### MATTERS FOR CONSIDERATION

### **ENVIRONMENTAL SERVICES**

### 375.3 DISPOSAL OF WHEELED LOADING SHOVEL

It is understood that the Council's insurers have advised that the wheeled loading shovel recently damaged beyond repair by the fire at Crosstagherty has been valued by the loss adjuster at £36,000 less insurance excess of £1,000. It is also the case that the plant remains the Council's property to dispose of as it sees fit.

#### IT IS RECOMMENDED that Council -

- 1. Accept the insurers valuation of £35,000 in respect of the 'written off' CASE wheeled loading shovel; and
- 2. Dispose of the plant as scrap, retaining the machine bucket.

In response to Alderman Campbell, the Director of Borough Services was unable to provide a cost to lift the 'written off' CASE wheeled loading shovel and the value of its scrap metal. He advised relevant companies would be invited to consider the work involved and provide a cost to complete the necessary work. It was hoped the value from the metal will offset costs involved.

It was proposed by Councillor Stevenson, seconded by Alderman Campbell and **AGREED:** 

### to recommend that Council -

- 1. Accept the insurers valuation of £35,000 in respect of the 'written off' CASE wheeled loading shovel; and
- 2. Dispose of the plant as scrap, retaining the machine bucket.

### 375.4 ROAD FREIGHT OPERATOR LICENSING IN NORTHERN IRELAND

It is understood that the statutory requirements in respect of Goods Vehicle Operator Licences is changing and that Council will probably by 1<sup>st</sup> April 2012 have to employ a competent person in order to continue its current range of waste management services. Subject to identifying a person within the Council's employ who would be willing to undertake the necessary role, it is estimated that the licence and training costs would be circa. £1,500.

It is further understood that in the new provisions which the DoE will introduce all those, including local authorities, who use goods vehicles over 3.5 tonnes in connection with any trade or business will have to advertise its licence application to have an operating centre and satisfy the Department that its vehicles are fit and serviceable at all times. It is estimated that to meet the conditions of an operators licence an additional budgetary provision of circa. £20,000 will be required in 2012-2013.

The Director of Borough Services gave background into road freight operator licensing and its implications to Council. In response to Alderman Campbell, the Director of Borough Services advised as in any organization there is a risk that an employee with

specialized training and/or experience will leave that employment. Further decision making is required.

### 375.5 BLUE BIN CONTRACT

The Director advised that given information currently available that it may be of some advantage to Council to work with other local cluster Councils and utilize Coleraine Borough Council's procurement policy to progress an interim blue bin service for the three month period ending 31<sup>st</sup> March 2012. He further advised that to progress this matter it would be necessary to set aside the Council's own procurement policy. He also advised that it was hoped that the next North West Region Waste Management Group contract would commence on 1<sup>st</sup> April 2012.

IT IS RECOMMENDED that Council in this instance set aside its procurement policy and proceed with a joint procurement exercise for the processing of blue bin recyclates with other cluster Councils namely, Coleraine, Limavady and Moyle.

It was proposed by Alderman Campbell, seconded by Councillor Atkinson and **AGREED:** 

to recommend that Council in this instance set aside its procurement policy and proceed with a joint procurement exercise for the processing of blue bin recyclates with other named cluster Councils.

### 375.6 CLOSURE OF CROSSTAGHERTY LANDFILL SITE

The Director updated Members in respect of further correspondence, dated 16<sup>th</sup> November 2011, received by the Chief Executive from the Department of the Environment, regarding meeting landfill closure requirements, etc., which dealt with the following matters - compliance notices to issue shortly, Limavady's plan now approved, closure plan funding arrangements and future financial arrangements.

### DOG CONTROL

### 375.16 DOGS (NORTHERN IRELAND) ORDER 1983 ARTICLE 29 – WORRYING OF LIVESTOCK

The Directorate is currently in receipt of a complaint made to the department on 22<sup>nd</sup> September 2011 by Mr xxxxx.

As a direct result of this complaint a full investigation was carried out by the Council's Environmental Warden.

Statements were recorded and the defendant has been interviewed regarding the matter.

The complainant describes having been travelling along the xxxxx Road on a cart pulled by a Gypsy Cob. The following is an excerpt of the complainant's statement:-

"I was travelling at a slow trot. Approximately 70 yards ahead of me I saw 8 or 10 Greyhound dogs on the road. I knew the dogs were xxxxx dogs. They were in the middle of the road just opposite xxxxx gate. They ran and jumped the gate back into xxxxx yard, that is the most of them. They jumped the gate as if there was no gate there. There was still two dogs on the right hand side of the road. The horse was watching the dogs on the right hand side. Suddenly to my left hand side two dogs came out of a field. The two dogs ran straight across the horse which caused the horse to bolt."

Mr. xxxxx describes these two dogs as blackish brown in colour. He then describes another two going by him in a flash.

"I was also conscious of a greyish brown coloured dog with a huge wound on his back sort of thing. He was continually running alongside the horse, I couldn't get him away."

Mr. xxxxx describes the horse and cart careering from one side of the road to the other followed the entire time by this greyish brown greyhound. The complainant finally lost control of the horse having been thrown out of the cart into the briars at the side of the road.

Mr. xxxxx received minor lacerations to his face, hands and arms. He suffered a bruised leg, sore neck and an injury to one of his fingers.

The Gypsy Cob received minor lacerations to its nose and around its mouth as a result of the incident.

This was indeed a very serious incident and could have had very serious consequences.

Due to the facts in this case *IT IS RECOMMENDED* that the keeper of the dogs be prosecuted under Article 29 of the Dogs (Northern Ireland) Order 1983.

Following discussion it was proposed by Alderman Campbell, seconded by Councillor Finlay and **AGREED**:

to recommend that the keeper of the dogs be prosecuted under Article 29 of the Dogs (Northern Ireland) Order 1983.

### **WELL BEING**

### 375.17 TACKLING INEQUALITIES AND PROMOTING WELLBEING – "A GUIDE FOR POLITICAL REPRESENTATIVES"

The above Guide, which provides an overview of how council services impact on health and wellbeing has been published and highlights the unique contribution that elected representatives have in supporting the development of policies and actions that effectively improve living conditions and life opportunities in communities. The guide was developed by Belfast Healthy Cities with support from NILGA, district councils and others.

### **EMERGENCY PLANNING**

#### 375.18 EMERGENCY PLAN

Arising from a meeting of party leaders convened by the Chief Executive on 14<sup>th</sup> November it was apparent that there was no political backing for the provision of a paid out of hours service in respect of the implementation of the Council's Emergency Plan. That being the case the Council's Emergency Plan has been amended accordingly (as circulated to members).

IT IS RECOMMENDED that Council approve the revised Emergency Plan.

Councillor Finlay advised that at the meeting referred to he had been speaking in a personal capacity and not on behalf of the group. The Director stated that he had tabled the report item in light of what he understood the outcome of the meeting to be. Councillor Finlay made it clear that all members ought to be given the opportunity to express their viewpoint as regards the manner in which the implementation of the Council's Emergency Plan out of normal working hours would be addressed. The Director suggested that he would withdraw his recommendation to enable the matter to be further considered by all members and that the issue could be finalized at the Committee's December meeting.

It was proposed by Councillor Finlay, seconded by Councillor Atkinson and AGREED:

The Chair asked that members note the figures above and highlighted the decrease in waste recovery and increase in timber recycling.

The Chair also highlighted an initiative by the Recycling Education Officer, asking for volunteers to take the challenge of trying to reduce a week's household waste to a small plastic carrier bag. The initiative was aimed at reducing black bin waste, change shopping habits and recycle more.

## 375.20 THE LANDFILL ALLOWANCES SCHEME (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 2011

The above Regulations, which come into operation on 22<sup>nd</sup> November 2011, amend the Landfill Allowances Scheme (NI) Regulations 2004 by providing for the use of the term "local authority collected municipal waste".

It should be noted that the Landfill Directive (1999/31/EC) set challenging targets for Member States to reduce the amount of biodegradable municipal waste sent to landfill.

Defra, on behalf of the UK, was in discussion with the European Commission in relation to the approach to reporting against the Landfill Directive diversion targets. The Commission raised serious concerns about the manner in which the UK interpreted the definition of municipal waste in relation to these targets. As a result and in agreement with the Devolved Administrations, the UK's approach to meeting these targets was revised.

The revised interpretation, which brings the UK more closely into line with the approach understood to be taken by other Member States, means that much more commercial and industrial waste than previously falls within the scope of the term "municipal waste".

As municipal waste will now relate to the subset of waste that is relevant to the Landfill Directive targets it can no longer be used as the term to cover the subset of waste that is covered by the Northern Ireland Landfill Allowance Scheme (NILAS). An alternative term was required and it has been agreed that the subset of waste to which NILAS applies is referred to as "local authority collected municipal waste".

At the request of the Chair, the Director explained that Landfill Directive targets remain the same, it is only the definition which had changed. He further explained the fines involved if NILAS targets are not met and intimated that additional work was required in order that Council would meet its NILAS target in 2012-2013 and in subsequent years.

In response to Councillor McAfee, the Director agreed that it would be very worthwhile post April 2012 to again publicise what could and could not be put in a blue bin. There was agreement that it was important to get necessary messages across to those in the home wishing to do the right thing as regards segregating their waste at source. Suggestions were made as to the approaches that might be used.

### 375.21 UK RESIDUAL WASTE TABLE

'Resource', a waste related magazine and website has just published a residual waste performance table for 250 local authorities across England, Scotland, Wales and Northern Ireland. The magazine and website are managed by 'Resource Media and Publishing' a highly regarded publishing and communications company with strong environmental principles. The information is extracted from Waste Data Flow and refers to the period April 2009 - March 2010.

Ballymoney is placed at no. 124 out of 250 local authorities and finished 8<sup>th</sup> in the Northern Ireland regional group with 300.7kg of residual waste per person per annum and 35% of household waste sent for reuse, recycling or composting. Magherafelt DC is the highest placed Northern Ireland local authority with figures of 252.6kg and 50%. The average figures for Northern Ireland are 316.70kg and 35.8%.

The public and media can often focus on recycling rates but in relation to NILAS and associated targets, residual waste levels are more important. In this regard, Ballymoney is better positioned than 18 other Northern Ireland Councils.

Ballymoney Borough Council position at 8<sup>th</sup> place is relatively good news and the Director of Borough Services highlighted the achievement obtained from budget available.

The Director asked members to note the achievement made to date as regards recycling performance within the Borough.

### **BUILDING CONTROL**

### 375.23 NORTHERN GROUP OF COUNCIL'S BUILDING CONTROL COMMITTEE: ANNUAL REPORT 2010-2011

The above document, received recently from the Group Chief Building Control Officer, Northern Group was circulated to members.

The Chair asked members to note that at item 2.3 (page 9) of the report the respective District Staff Complement working at each of the five constituent councils comprising Northern Group Building Control was detailed.

### **PLANNING**

### **375.24 PLANNING LEGISLATION**

Members are advised that DoE has made two orders which will come into operation on 1<sup>st</sup> December 2012 –

- (1) Planning (2011 Act) (Commencement No. 1) Order (NI) 2011 and
- (2) Planning (2011 Act) (Transitional Provisions) Order (NI) 2011.

The "Commencement Order" commences sections 247 and 248 of the 2011 Act. Section 247 details the Assembly controls which apply to regulations and orders under the 2011 Act and section 248 provides for a new 5 year time period for taking enforcement action.

The "Transitional Provisions Order" sets out how enforcement cases will be handled by the Department where enforcement action has been initiated under the Planning (NI) Order 1991 at the time the new period (5 years instead of 4 and 10 years) is introduced.

#### 375.25 WIND TURBINE AT CROSSTAGHERTY PROPOSAL

The Director informed members of an approach made from a local architect, on behalf of a group of local businessmen, regarding the possibility of utilising land at Crosstagherty for a wind turbine to produce energy to supply to the grid. He referred to correspondence received which was not very specific, but simply sought Council sanction to permit enquiries and investigations to be made as regards the viability of wind energy generation at the site. In the ensuing discussion there was agreement that this could be something that Council could agree to in principle subject to receipt of a business case from the interested group.

It was proposed by Councillor Finlay, seconded by Councillor Atkinson and AGREED:

to recommend that the matter be discussed at December Committee in light of further information received

### 375.26 DIRECTORATE CAPITAL PROJECTS 2012-13

The Director of Borough Services presented the proposed Directorate capital projects 2012-2013. He explained the reason for the proposals, which in the main, related to the necessary replacement of very aged vehicles and resurfacing work which if not addressed would lead to greater future expense. He advised that as work was ongoing regarding some of the matters, these cost estimates would be furnished to members when available. He drew attention the options to be considered to improve the waste handling and transfer facility at Crosstagherty following the recent fire and advocated that action be taken so that the necessary space was created not only to deal with the present four waste streams but also allow for future need. He explained that when built the building was designed to handle two waste streams – mixed dry recyclates and waste being sent to landfill.

The Director also highlighted in particular the fact that the number of staff working in regulatory services [both building control and environmental health] was less than elsewhere within the cluster notwithstanding the services delivered and the additional services to be delivered from April 2012 given the extensive legislative changes which would take effect then. The Director dealt with member questions. It was agreed that a copy of the Director's presentation would be emailed to each member.
