#### 368.2 BALLYMONEY CEMETERY MEMORIAL

### LEISURE SERVICES

#### 368.5 MARY PETERS TRUST - REQUEST FOR FINANCIAL SUPPORT

Dame Mary Peters, President of the Mary Peters Trust (previously the Ulster Sports Trust) has written to the Council seeking financial support in 2010/11 towards the Trusts sporting awards programme. In 2009 the Trust awarded over £56,000 to 175 young people representing over 30 sports. Awards were made to a young person who resides in the borough.

Committee is asked to consider the request.

The Director advised members that Ballymoney Sports Advisory Committee gave grants to local sporting athletes in the borough.

to recommend that Council note the request from Dame Mary Peters, President of the Mary Peters Trust seeking financial support in 2010/11 towards the Trusts sporting awards programme.

#### 368.6 BALLYMONEY AMATEUR SWIMMING CLUB

The Chairman of the Ballymoney Amateur Swimming Club has written to the Council advising of the clubs plans to hold a fund-raising Gala dinner in the Joey Dunlop Leisure Centre on Saturday 20<sup>th</sup> March 2010 and are seeking permission to have an occasional bar licence for the event.

### 368.7 GOOD RELATIONS GRANTS

The following applications for grants were considered –

to recommend that Council grant £285 to Bushside Independent Flute Band for assistance towards a St. Patrick's Night event of music, song and dance and £350 to Stranocum Ulster Scots Cultural & Heritage Society for assistance towards an Alternative St. Patrick's Night event of music, dance, song and poetry.

#### 368.9 A HISTORY OF THE WORLD: DERRYKEIGHAN STONE

The Director informed members that The Derrykeighan Stone has been selected to appear in 'A History of the World' project. She advised that a 'History of the World' is a partnership between the BBC, the British Museum and museums in Great Britain and Northern Ireland. The project celebrates objects that have a story to tell. The Derrykeighan Stone has been selected as one of the top 25 objects in Northern Ireland. The objects will be featured in BBC television programmes.

### 368.10 GOOD RELATIONS GRANT SCHEME

The Director reminded members that the 1<sup>st</sup> open call for applications for the Good Relations Grant Scheme was due to be advertised in January 2010.

She advised members that a number of groups were enquiring if there would be the Community Festival fund grant scheme in 2010/11 and that she had informed them that this would not be known until the Council had set the rates and agreed the budgets for 2010/11 around mid February.

Councillor McCamphill suggested that the advertising date be changed to after the rates were set.

The Director agreed to look at revised dates for the 1<sup>st</sup> open call for applications and report to the next committee meeting.
