390.1 MINUTES MEETING NO 389 - 17TH NOVEMBER 2011

It was proposed by Councillor Robinson, seconded by Councillor Atkinson and **AGREED**:

390.8 REPLACEMENT OF NIE POLE MOUNTED TRANSFORMER

NIE has written seeking Council permission to replace a pole mounted transformer at Riverside Park, Dervock (Council property) with a packaged kiosk substation on the usual terms.

IT IS RECOMMENDED that Council grant the permission sought by NIE on the terms offered.

It was proposed by Councillor Robinson, seconded by Alderman Cousley and **AGREED**:

to recommend that Council grant the permission sought by NIE on the terms offered.

390.9 DRUMBOLCAN PARK, RASHARKIN

Members will be aware that, in response to representations made by Rasharkin Community Association (first discussed in 2007) Council in December 2009 agreed in principle, to facilitate the request from Rasharkin CA for permission to develop the area of land between the soccer pitch and the play park at Drumbolcan Park in order that the Association might pursue funding applications covering 100% of the project capital costs.

It is understood that the Community Association/Groundwork partnership has secured the necessary funding to progress the project envisaged under the Sharing our Space programme – a 3 year EU PEACE III initiative. Consultation has been undertaken with the local community during October/November and in that regard what may be provided has now been detailed on plans (which are to be found as Appendix A to this report).

IT IS RECOMMENDED that Members consider these proposals for further facilities on the Council's land at Drumbolcan Park and that Committee comment as to acceptability, etc.

Following discussion on the plans presented, it was suggested that in order to move forward it might be best if Council reps met with members of the Community Association to discuss the issues highlighted. The Council reps indicated that 9th, 11th or 18th January 2012 would be suitable dates to meet at Drumbolcan Park at 7.30pm.

It was proposed by Councillor Robinson, seconded by Alderman Cousley and **AGREED:**

to recommend that the Committee Chair, Councillor Atkinson, Councillor Blair, Councillor Halliday, Councillor McLaughlin together with the Director meet with representatives of Rasharkin Community Association.

390.10 RASHARKIN COMMUNITY PLAYGROUP

Correspondence has been received from the Chair of the above group, makes use of a `room' at Rasharkin Community Centre regarding the possibility of an extension to its facilities. Following discussion with Rural Development Programme staff, the group understands that there may be an opportunity under the Basic Services Measure for a grant at 75% for the extension envisaged. The Chair also advises that in the interim the group has submitted an expression of interest to the RDP. The group has asked if its proposals are something which Council would consider and take the lead on.

IT IS RECOMMENDED that Committee consider the Rasharkin Community Playgroup proposal in respect of the Council's property at Drumbolcan Park, Rasharkin.

It was proposed by Councillor Halliday, seconded by Councillor Atkinson and **AGREED:**

to recommend that Council grant permission for the above memorials to be erected in Ballymoney Cemetery, subject to usual requirements.

390.13 BALNAMORE & STRANOCUM COMMUNITY BUILDINGS

The Council's consultants have advised that the new community buildings being provided both in Balnamore and Stranocum are to be handed over on 21st December 2011. The project has been successfully delivered in that it has been completed both within budget and the time envisaged for the construction process.

The Director suggested that members might wish to view the facilities provided and suggested that a tour of the three community centres could be arranged. The afternoon of Friday, 30th December was agreed as a suitable date with members meeting at the entrance to Riada House at 2.00pm.

It was proposed by Councillor Stevenson, seconded by Councillor Atkinson and **AGREED:**

to recommend that a tour of the three new community centres be arranged for 30th December commencing at 2.00pm.

Given that all three community buildings (Ballybogey, Balnamore and Stranocum) have been delivered within budget, Committee is asked to consider utilizing some of the savings achieved to purchase equipment (such as tables and chairs) for each location as such provision may be in the Council's best interests.

It was proposed by Councillor Robinson, seconded by Councillor Atkinson and **AGREED**:

to recommend that Council purchase equipment such as tables and chairs for Ballybogey, Balnamore & Stranocum Community Buildings.

Councillor Stevenson acknowledged the fact that the work was completed within budget and in a timely manner and expressed his thanks.

390.14 BALLYMONEY CONNECT2 PROJECT

Each of the 79 UK wide `Connect2' projects, including Ballymoney, will feature a portrait bench. Each bench will comprise three life size "local" characters cast in steel and chosen by the community. With the assistance of colleagues based at Ballymoney Town Hall, six characters representing Ballymoney's working/industrial history have been selected and local people are now being asked to vote for the final three. Votes can be cast by phone or email following a number of press releases in the local papers and on the Council's website. A display has been set up at the Town Hall and Translink have facilitated voting at Ballymoney Railway Station. Sustrans and Council staff have also been involved in collecting votes house-to-house as regards those properties in the immediate vicinity of the Connect2 `area' and it is pleasing to report that a very positive response to both the railway bridge and the public art aspect of the project has been received. It is anticipated that the outcome of the portrait bench public vote will be announced in January 2012.

Members having viewed the pen portraits relating to each 'character' then voted for their preferred three.

390.15 AMENITIES CAPITAL PROJECTS

During the report period work has progressed as regards the undernoted amenities projects: Cloughmills Bio Park, Dervock Community Facilities and Glebeside Facilities

1. Cloughmills Bio Park

The Director gave an overview of the total concept as regards the Council's Old Mill Site and circulated two sets of plans. The first related to the 'entrance' lands and the facilities to be provided there with funding from RDP. The second set of plans which had been drawn up by C.A.T. in conjunction with Groundwork detailed the group's proposals for the land to be leased from Council and developed with funding from the Big Lottery; this project to be delivered by December 2012. The Director responded to member questions and intimated that C.A.T. had been established as a limited company. He advised that Council could assist practically with this part of the overall project by facilitating capital purchases, something with which the funder was content.

It was proposed by Councillor Atkinson, seconded by Councillor Robinson and **AGREED**:

to recommend that Council endorse the proposals for the development of its land at Cloughmills and that it also facilitate C.A.T. with capital purchases in respect of its delivery of its part of the Cloughmills Bio Park Project.

2. Dervock Community Facilities

The Director updated members advising that a planning application had been lodged, mentioning that this cost £2,680. He indicated that even were the present funding application to the RDP to be successful [and there were indications that the measure was considerably oversubscribed] a funding gap remained.

3. Glebeside Facilities

The Director circulated the plan relating to facilities at Glebeside which had accompanied the Council's planning application. He drew attention to the fact that 'fixed' equipment would be used at the games arena. He intimated that in order to deliver the project, which would be phased, it was necessary to secure land from the Housing Executive to provide the planned grass pitch.

Councillor Stevenson expressed his appreciation at the work that has been done.

This being all the business the meeting closed at 9.15pm.

Report of meeting no.3 held in the McKinley Room, Riada House, on Tuesday 13th December 2011 at 7.00 p.m.

1. Draft Agreement

DCLS advised she had prepared a draft agreement between Council and groups to operate non-corporate buildings (NCBs) and discussed with Solicitor. She sought views on – form of agreement, duration of agreement, notice of termination, Council representation and fee.

1.1 Form of Agreement

Lease or Licence - to be reviewed with Solicitor.

Roles and responsibilities already agreed by Working Group have been incorporated into the draft agreement.

Noted that Council policy was to have an agreement with a legal entity. Building remains a Council asset.

1.2 Duration.

Taking account of impending RPA agreed that agreement be for an initial five year period with annual review (2012-2017).

DCLS advised that groups had indicated that further funding applications were being pursued. Noted that any new funding applications involving Council land/buildings would be subject to application to and consideration by Council. DCLS advised that information on applications pending and approved was available on the funding database and she would provide information on same.

1.3 Notice of termination

Agreed two months either party.

1.4 Council representation

With regard to Councils policy to enter into agreements with legal entities DCLS to seek further advice from Solicitor as to whether it would aid governance arrangements to have Council representation on the board of the limited company.

Noted that community/development associations would continue to exist as currently with Council representation.

Noted also that limited companies exist in Dervock and Cloughmills with no Council representation requested.

CE to update and issue guidance in respect of councillors acting as directors of limited companies.

1.5 Fee

Estimated operating costs and details of facilities provided by DBS. Based on this information HCDS seeking advice on rental value. OCE committed to assist

new groups to develop business plans and policies for operation and administration of the community facilities.

2. Buildings Update

DBS advised that all buildings would be available prior to Christmas.

3. Status of Proposed Management Committees

DCLS updated the meeting on discussions with community association representatives and difficulties being experienced in getting a meeting with group nominees to discuss. Agreed meetings be arranged before end of calendar year with individual nominees.

- Stranocum Village Forum meeting held which was inconclusive, with further meeting planned for mid-January, to be facilitated by a representative from community network. Ald. Campbell undertook to make arrangements for nominees from Stranocum to meet with DCLS.
- Ballybogey –representatives nominated with date to be arranged. Charity Status applied for and would pursue moves to form limited company.
- Balnamore to meet in January with regard to taking forward limited company status, facilitated by supporting communities.
- Rasharkin and Killyrammer Affirmed that the process applying to the groups associated with the newly provided community centres also applied to the existing facilities at Rasharkin and Killyrammer, with DCLS still to meet with existing management committees.
