# 89.5 PLANNING (GENERAL DEVELOPMENT) (AMENDMENT NO.2) ORDER (NORTHERN IRELAND) 2013

The Department of the Environment has made a Statutory Rule entitled "The Planning (General Development) (Amendment No.2) Order (Northern Ireland) 2013" (S.R. 2013 No.210), which comes into operation on 30<sup>th</sup> August 2013.

The main purpose of this Statutory Rule is to amend the Planning (General Development) Order (Northern Ireland) 1993 (S.R. 1993 No. 278) (the "GDO") to:-

- revise existing permitted development rights to increase the size area limitation of PD rights for agricultural buildings from 300 to 500m<sup>2</sup>; and
- provide new permitted development rights for small-scale anaerobic digestion plant on an agricultural unit .

In addition a minor technical amendment has been made to clarify that the GDO cannot grant planning permission for certain development that falls within the scope of the Planning (Environmental Impact Assessment) Regulations (Northern Ireland) 2012 (S.R. 2012 No.59) unless the Department has determined that it is not EIA development.

### 89.6 PROPOSED SALMON CONSERVATION REGULATIONS (DCAL) (CC 88.17)

The issue was deferred for further discussion from the August Consultation Committee meeting.

DCAL proposes to introduce a series of Regulations to implement mandatory catch and release for salmon and sea trout angling and to prohibit commercial salmon and sea trout netting. The proposed regulations will also introduce some other minor amendments which are designed to update and improve the regulatory process.

Alderman Kennedy referred to the issue of controlling movement of fish in the rivers and who can fish them. He expressed the view that fish should be allowed to return to their natural habitat for breeding and that there should be natural fish stocks in the rivers rather than those who own the rivers having control. He stated that he would not be supporting DCAL if this is the case. Councillor Finlay concurred with Alderman Kennedy's remarks.

The closing date for receipt of responses is 27<sup>th</sup> September.

No comments were offered.
