## 423.1 DECLARATIONS OF INTEREST

There were no declarations of interest.

## 423.2 MINUTES – MEETING NO 422 – 21<sup>ST</sup> OCTOBER 2014

It was proposed by Alderman Kennedy, seconded by Councillor Stevenson and AGREED:

that the minutes of Meeting No 422 on 21<sup>st</sup> October 2014, as circulated, be confirmed as a correct record.

## LEISURE SERVICES

With the consent of the Chair, the Director of Central and Leisure Services presented two additional items (423.6 and 423.7)

## 423.3 PRESENTATION FROM DALRIADA SCHOOL

The Mayor welcomed representatives from Dalriada School to the meeting to present the school's Sports Facilities Master Plan. The presentation is attached as Appendix 1.

Mr Skelton and Mr Morrison answered questions from the Mayor relating to the school's provision for rugby and other sports and what funding, if any, was available from the North Eastern Education and Library Board or Department of Education. The Mayor and Councillor Stevenson made reference to the hockey pitch at the Joey Dunlop Leisure Centre provided by the Council and used by Ballymoney Ladies Hockey Club which had recently been refurbished.

The Chairman thanked Mr Skelton and Mr Morrison for their presentation which concluded at 7.20 pm. Mr Skelton and Mr Morrison left the meeting at this time.

It was proposed by Councillor Finlay, seconded by Councillor Cavlan and AGREED:

#### to recommend that Council note the presentation

## 423.4 CAUSEWAY COAST & GLENS INTEGRATED CULTURE, ARTS AND HERITAGE STRATEGY

The Director advised that Ballymoney is the Lead Council for the procurement of consultants to produce a Culture, Arts & Heritage Strategy for 2015-2020 for the Causeway Coast & Glens District Council.

Council at its meeting on 3<sup>rd</sup> November 2014 granted committee council powers to deal with this item of business.

The tender for the procurement of consultants was publicly advertised on 17<sup>th</sup> October 2014, with the closing date for receipt of tenders being 7<sup>th</sup> November 2014. Tender documents were requested by 12 organisations with 1 tender being received by the deadline. This tender was opened on 7<sup>th</sup> November by the Chair of Committee and the Director of Central & Leisure Services. The Director advised that she had consulted the Chief Executive of the Causeway Coast & Glens Council and as only one tender was received it was agreed not to proceed with the

work at this stage but to revisit the matter again in January 2015 with a view to retendering. She advised that the tender was not evaluated.

It was proposed by Councillor Finlay, seconded by Councillor Cavlan and AGREED:

not to proceed with the strategy work as only one tender was received but to consider the matter again in January 2015 with a view to retendering.

## 423.5 BALLYMONEY BOWLING CLUB – REQUEST FOR FINANCIAL SUPPORT

The Honorary Treasurer of the Ballymoney Bowling Club has written to Council requesting financial support towards the cost of improving its facilities. The Treasurer advises that the Club was founded in 1904 and is one of the oldest clubs in the Borough. In the 110 years of the club's history, members have brought great distinction to the Borough both at individual and team level and are currently recognised as one of the premier bowling clubs in Ireland. The Club plans to improve accessibility to its facilities recognising the positive impact that improved accessibility will have on players, officials and spectators both local and visiting. The Club is scheduled to have the Presidency of both the Men's and Ladies Associations in 2016 which will bring many visiting players and officials from all over Ireland and would wish to have their facilities updated for these events.

The Director of Central & Leisure Services advised members that the estimated cost of the works amounted to £6,500. She drew member's attention to Council's decision with regard to not providing funding to outside bodies for capital purposes.

It was proposed by Alderman Kennedy, seconded by Councillor Cavlan and AGREED:

to recommend, in the light of Council's policy not to provide funding for capital purposes, that Council note the request.

#### 423.6 NEW COMMUNITY GRANT SCHEME

The following applications for grants were considered. :-

- (v) The Braig Drag Hounds for assistance towards a Children's Meet.

- (vi) Tullaghans Flute Band for assistance towards a Robert Burns Cultural Event.
- (vii) Ballymoney Renewal Group Heritage Sub Group for assistance towards a Room for Reflection Event.
- (viii) Ballybogey Community Association Limited for assistance towards a Youth Carol Service.
- (ix) St Patrick's Church of Ireland for assistance towards a Robert Burns Cultural Night.
- (x) Glebeside Youth Club for Assistance towards Christmas Switch On activities.
- (xi) Riada Football Club for assistance towards a community football match.

The Director advised that all groups meet the criteria for funding in that they had not received a grant previously either from the Community Festival Fund, Community Support or Good Relations Grants.

**IT IS RECOMMENDED** that grants of £350.00 each are awarded to the above 11 groups.

It was proposed by Councillor Finlay, seconded by Councillor Stevenson and AGREED

## 423.7 JOEY DUNLOP LEISURE CENTRE

The Director of Central & Leisure Services advised that the existing planning permission for the conversion of the shale pitch to a multi use 3G pitch at the Joey Dunlop Centre which is due to expire, has been renewed for a further five years.

#### AMENITIES

## 423.8 PROVISION OF ELECTRICITY SUPPLY TO COUNCIL OLD MILL PROPERTY

Councillor Finlay requested that work be undertaken to investigate the cost of providing electricity at the Council's Old Mill site to assist with the activity currently being undertaken there by CCAT.

It was proposed by Councillor Finlay, seconded by Councillor Robinson and AGREED:

to recommend that cost of providing electricity to Cloughmills Old Mill site be obtained from NIE.

## 423.9 BUS SHELTER AT FINVOY

At the request of Councillor Finlay the Director undertook to provide him with an update on the matter.

#### 423.10 PROVISION OF SCREEN AND PROJECTOR AT TOWN HALL

Councillor Stevenson requested that consideration be given to the provision of a retractable screen and back projector at the Town Hall for use in the main auditorium. Alderman Kennedy expressed the view that if the equipment is purchased there should be a charge made to those requesting to use it.

The Director agreed to ascertain the cost for the purchase of such equipment and also research what the cost to hire such equipment might be.

#### 423.11 BLUE SIGNAGE IN CONSERVATION AREA

Councillor Stevenson also raised the need to refurbish the conservation area blue signs. The Director intimated that he would look at this issue also.

#### 423.12 AMENITIES PROJECTS UPDATE

IT IS RECOMMENDED that Committee note the following information -

1) Dervock War Memorial Garden Scheme

This scheme was successfully delivered in advance of this year's village and district remembrance ceremony on 9<sup>th</sup> November. The work undertaken was to a very good standard and has been well received by Royal British Legion representatives and others within the local community.

- 2) Ballymoney Town Hall Redecoration
- 3) Riada House Redecoration
- 4) Riverside Park, Ballymoney River Restoration Scheme
- 5) Rasharkin Community Centre

These schemes are progressing satisfactorily and remain on target as regards their respective delivery dates.

- 6) Additional Pitches At Riada Playing Fields
- 7) Festive Lighting Scheme Extension

Both these projects have been commenced.

The Director advised that in respect of item 7, Festive Light Scheme Extension - the only element of the scheme able to be installed this year was the addition of strings at Victoria Street.

Councillor Robinson congratulated the Director on the redecoration work carried out at the Town Hall.

It was proposed by Councillor Robinson, seconded by Councillor McAfee and **AGREED:** 

## to recommend that Council note the update.

#### 423.13 LAND ADJOINING DERVOCK WM GARDEN

Further to Minute LAC413.14.3 **IT IS RECOMMENDED** that members note that the Council valuer has advised that the owner of the land has indicated that he "would have no intention in accepting less for the site than he paid for it some years ago before the property crash" and such a figure could not be recommended to Council in the present circumstances.

It was proposed by Councillor Robinson, seconded by Councillor McAfee and AGREED:

to recommend that Council note the information from Council's valuer as set out above.

#### Alderman Kennedy rejoined the meeting at 8.05 pm.

#### 423.14 OTHER AMENITIES PROJECTS

The Director reported on the undernoted projects. **IT IS RECOMMENDED** that Members note that it is hoped, where necessary, to determine what is to be done or agree the approach to be taken –

## 1) Play Area Refurbishment

The Director advised that the present budget of £175,000 would cover the cost of refurbishing the play areas at Seacon, Finvoy and Westgate and the landscaping of the Fernbank and Lislagan sites. He intimated that it was proposed to incorporate a 'new team swing' as part of the landscaping proposed at both Fernbank and Lislagan. Drawings of this work and what could be done at Seacon, Finvoy and Westgate were circulated. He provided an update as to the work undertaken regarding the Council's request to purchase land at Scally Park from the Housing Executive for a toddler play area. The Director advised that were members minded to increase the budget it ought to be possible to refurbish Carnany and provide the new toddler park at Scally Park plus pay fees on the total scheme within the limits contained in the DoE Minister's Direction re. capital

spend. Members were also made aware that this still left some play areas in need of refurbishment. During the ensuing discussion the Director responded to Member questions.

It was proposed by Councillor Stevenson, seconded by Councillor Halliday and **AGREED:** 

to recommend that Council increase the budget for play area refurbishment and landscaping from £175,000 to £249,000 and proceed with play area refurbishments at Seacon, Finvoy, Westgate and Carnany; provide the new toddler play area at Scally Park [subject to the land being obtained] and undertake the landscaping proposed for Fernbank and Lislagan.

\* Councillor McLaughlin left the meeting at 8.20 during the discussion

Alderman Kennedy and Councillor Cavlan left the meeting at 8.30 pm during the discussion.

- 2) Kickabout Refurbishment
- 3) Killyrammer Community Centre
- 4) Ballymoney Social Centre
- 5) Riverside Park, Ballymoney Improvement Scheme

The Director, at the meeting, gave a brief update on each of the above projects, asking members to make recommendation as to what Council ought to do in each instance.

#### Kickabout Refurbishment

It was proposed by Councillor Robinson, seconded by Councillor Stevenson and **AGREED:** 

# to recommend that this be re-considered when the surplus as at 31<sup>st</sup> March is known.

#### Killyrammer Community Association

The Director outlined what could be done within the limit on capital spend set by the DoE Minister and advised that it was necessary, prior to committing to any such scheme, to consult with the Community Association. Alderman Campbell intimated that it was important to consult as he believed the Association might prefer the new build option.

It was proposed by Councillor Stevenson, seconded by Councillor Robinson and **AGREED:** 

to recommend that the matter be deferred until after consultation has taken place with the Community Association.

## **Ballymoney Social Centre**

The Director advised that the work required at the premises could not be kept under the £250,000 ceiling for capital projects and also advised as to the present usage of the premises. Members discussed the level of use at the centre and the poor car parking facilities. Councillor Stevenson expressed the view that the work could be undertaken using the £1M of MRP. He reiterated his view that there would be no objection by Causeway Coast & Glens or the DUP party grouping on that Council to the spend if the project is within current budgets.

It was proposed by Councillor Stevenson to recommend that Council make representation to Causeway Coast & Glens Council that the work at Ballymoney Social Centre be undertaken. Councillor Stevenson expressed his disappointment that his motion did not find a seconder.

## **Riverside Park**

The Director updated members regarding what had been agreed at the previous meeting concerning adopting a phased approach to the proposed work. He initimated that flexibility ought to be built into the tenders invited so that work might be completed in a particular part of the park [for example park central] if it were necessary to do so given the cost of the work and the spending limit. He then responded to Member questions, advising that out of a £500,000 overall budget £155,000 plus fees was committed to the River Restoration Scheme. Councillor Stevenson referred to the possible MRP funding which may be available to Council and requested that Council make representation to Causeway Coast & Glens in order to proceed with the total scheme. Councillor Robinson concurred with Councillor Stevenson's views. The Director advised that before any such proposal could be put to the Causeway Coast & Glens Council, Council needed to determine what the total scheme comprised. He pointed to the options discussed previously and in more detail at the October Committee meeting which had not been agreed.

## \* Councillor Halliday left the meeting at 9.35 pm.

## 423.15 BUS SHELTER AT KILRAUGHTS ROAD, BALLYMONEY

**IT IS RECOMMENDED** that Committee again consider this issue deferred from the previous meeting and make a decision/recommendation to Council regarding the matter.

The Director again summarized the position regarding Councillor Stevenson's request. Councillor Stevenson advised that he now reluctantly accepted the position.

#### 423.16 CLOUGHMILLS OLD MILL BUILDING PROJECT

**IT IS RECOMMENDED** that members note that the stage 1 assessment in respect of the Council's re-submitted funding application concerning the above project was conducted on 10<sup>th</sup> November. It is anticipated that the outcome of this will be known prior to Christmas.

It was proposed by Councillor Robinson, seconded by Councillor Stevenson and **AGREED:** 

to recommend that members note that the stage 1 assessment in respect of the Council's re-submitted funding application concerning the above project was conducted on 10<sup>th</sup> November.

#### 423.17 SUCCESSFUL BIKE WEEK & COUNTRYSIDE EVENTS PROGRAMMES

**IT IS RECOMMENDED** that members note it has been another very successful year for the annual outdoor recreation programmes organised by Amenities on behalf of Council with over 500 participants enjoying the various activities on offer.

The **Countryside Events Programme**, which has been running for 16 years since 1998, attracted 235 participants to join in diverse activities such as fishing, bat detection, Nordic walking and biodiversity hunting. This year, spurred on by the Giro, Ballymoney's **Bike Week** events saw 266 cycling participants of all ages taking part in cycle rides from less than 1 mile to over 18 miles. It was particularly pleasing to have the involvement of local primary schools who signed up to cycle training in advance of an on-road Bike to School Day.

Thanks go to the wide range of partner organisations and individuals involved who help to make both Bike Week and the Countryside Events Programme in Ballymoney a continuing success. Particular thanks to Travelwise NI for their ongoing 50% sponsorship of Bike Week to the tune of £1800 this year. Picture summaries of all the activities were circulated for member's information.
