997.1 MAYOR'S REMARKS

997.3 MINUTES OF COUNCIL MEETING NO 996 – 7TH APRIL 2014

Responding to a query from Councillor Robinson, the Director of Borough Services advised that a report on the options available for further enhancements to Killyrammer Community Centre would be tabled the June Committee Meeting. *

5.3 Grant Applications

3.1 Community Festival Fund

 Ballymoney & District Cultural & Heritage Society for "The Great War Remembered 1914-2014 on 1st & 2nd August 2014.

The Council has already awarded this Society £12,000 towards its events on 1^{st} & 2^{nd} August. Under the criteria for the Community Festival Fund, they would be entitled to £1,200.

The Director of Central & Leisure Services advised that to award the grant to the above group would mean that every other applicant would receive £90 less. She said that the total grant aid including Council's £12,000 is £37,000 and that Council would need to be mindful of costs which she indicated are estimated at £32,000.

Councillor McAfee expressed the view that it would be unfair to take funding away from other events to give additional financial support to this event which has received a lot of funding so far. Councillor Cavlan concurred with Councillor McAfee. Councillor Stevenson requested advice as to the eligibility of the application and the funding already received.

The Director of Central & Leisure Services advised that she would need to ascertain the level of funding already secured by this group to ensure that they do not receive more funding than that the festival cost.

Councillor Finlay advised that the cost of this weekend is going up day by day. He expressed the view that if Council receives an application which meets the criteria, it should be included. The Director advised that the Council had agreed the criteria for the grant scheme prior to it being advertised and that all applications were assessed under the set criteria by the assessment panel. It was proposed by Councillor Stevenson, seconded by Councillor Cavlan and **AGREED**:

that all groups, as detailed in Appendix 1, applying for the Community Festival Fund, who meet the criteria, with the exception of (i) above which was deferred to the next meeting should be awarded funding.

Councillor McKeown also expressed the view that this matter needs to be clarified. The Director of Central and Leisure Services advised that unauthorised work has been taking place which needs to be addressed and this matter will be tabled for discussion at the next meeting of Committee. It was also agreed that a date be arranged to look at this and the access arrangements.

997.8 DEVELOPMENT REPORT – APRIL 2014

8.1 World War One Centenary Ballymoney Legacy Programme

The Head of Corporate & Development Services advised that 14 applications were received in response to the open call for expressions of interest for assistance under the above programme.

Funding through the legacy programme must relate specifically to WW1 and its centenary, with some form of legacy beyond 2014. The maximum financial award under the scheme is £1,500 and there would only be one call for applications, with projects requiring to be completed by 31st December 2014.

The maximum grant for any project is £1,500 and the total fund is £15,000.

11.1 NWRWMG Food Smart Project

The proposed North West Region Waste Management Group FOOD SMART project is a collaborative venture which seeks to encourage consumers to adopt a new relationship with food and <u>reduce food waste</u>. It moves beyond the traditional Love Food Hate Waste messages to challenge the notion that many do not waste food.

Ballymoney officers, on behalf of the seven constituent councils of the NWRWMG, have taken the lead in submitting by the deadline set (16th April 2014) a funding application to the WRAP Rethink Waste Revenue Fund.

Furthermore the Framework Agreement* (Chapter 2, para 12.8), states that Ballymoney Borough Council shall ensure that a Food Analyst is appointed to carry out examinations and analyses of food samples. In making these appointments, all relevant legal requirements and Codes of Practice shall be satisfied.

The qualifications required by Analysts are set out in the Food Safety (Sampling and Qualifications) Regulations (NI) 2013. The Environmental Health Department is satisfied that the following persons, who are employed by Minton, Treharne & Davies Limited and Worcestershire Scientific Services, fulfil the requirements of the Regulations for appointment as Public Analysts on behalf of the Council.

11.14 Affordable Warmth Consultation Response

The Department for Social Development's Fuel Poverty Strategy "Warmer Healthier Homes" committed the Department to improving partnership working and increasing innovation to tackle fuel poverty in Northern Ireland.

The public consultation document "From Fuel Poverty to Achieving Affordable Warmth" proposes a new approach to assisting those households most affected by fuel poverty in Northern Ireland. The Department proposes to introduce a new model for the delivery of energy efficiency of low income households which builds on the success of Affordable Warmth pilots which the Department ran with Councils and the Housing Executive in 2012 and 2013. The new model will involve the Department working in partnership with the:

- University of Ulster to produce maps and information at Council level on areas where fuel poverty is most prevalent;
- Council staff to carry out initial visits to targeted households identified by the University to assess eligibility for assistance;
- Housing Executive to assist the householders and to arrange delivery of energy efficiency improvement measures by local installers.

The Department proposes to introduce a new Affordable Warmth Scheme which will make some key changes to the;

- Qualification criteria; and
- Energy efficiency measures available.

This document sets out proposals for:

- Improved targeting;
- Improvements in future partnership working;
- Assisting the private rented sector;
- Changes to the eligibility qualification criteria;
- Changes to the energy efficiency measures available;
- Management of self-referrals to the scheme; and
- Client contribution.

The Consultation Document and proposed response was circulated.
