CHIEF EXECUTIVE'S REPORT – JUNE 2009:

RPA Update:

- **Draft Responses to Consultations:** Members approved the draft responses to the consultation documents 'The Local Government Reform Establishment of Transition Committees in Statute' and 'Severance Arrangements for Councillors' for submission by 3 June 2009.
- Voluntary Transition Committee: The Chief Executive tabled for information minutes of the Voluntary Transition Committee meeting held 26 March 2009. He said that a workshop had been held on 21 April 2009 which reviewed the role of the Transition Committees, the current processes for bringing the formulation of the new Council forward and had began the process of identifying the key tasks and vision of the emerging Council.
