# PLANNING AND DEVELOPMENT SERVICES COMMITTEE

# 6 MAY 2004

Minutes of meeting held in the Council Offices, 7 Connell Street, Limavady at 2 pm on the above date.

# PRESENT:

Aldermen M Carten, J Dolan and G Robinson. Councillors A Brolly, B Douglas (chair), L Cubitt, M Coyle, G Mullan, M McGuigan, J Rankin and E Stevenson.

### **MINUTES:**

Minutes of meeting dated 1 April 2004 were approved and signed on the proposal of Councillor Cubitt, seconded by Alderman Dolan.

### **ROADS SERVICE - TRAFFIC MANAGEMENT**

The Chairman welcomed Mr John Young, Senior Traffic Engineer, Roads Service to the meeting who expressed his sadness on hearing of the death of a vehicle driver at Rathmore Road.

Members expressed their overall satisfaction with the by-pass but highlighted to Mr Young their concerns on traffic management at key locations.

Mr Young explained that in some cases, a roundabout could help the flow of traffic for smaller roads but often this lead to main road traffic being slowed down and that Roads Service had to consider a number of factors before deciding to construct a roundabout. He added that a survey undertaking by Roads Service did not show there was a major problem or significant delays in traffic in the Limavady area.

Mr Young responded to Councillor Rankin concerns regarding traffic buildup at the loop road at the bus station and said that the option of an roundabout was complicated as the main sewage system was located inches below the ground. He added that traffic studies had been undertaken to find a practical solution and it was considered that the present traffic system was the best option.

Members felt strongly that the traffic management associated with this link should be reviewed. Councillor Cubitt suggested that a possible solution could be a one way system and requested that this be introduced on a temporary basis.

Councillor Cubitt highlighted the issue of speeding on the by-pass and was advised by Mr Young that the Police Service of Northern Ireland was responsible for speeding offences and that setting a speed limit on the by-pass would not solve the problem.

On Councillor Lowry's behalf, Councillor Coyle suggested that a roundabout should have been included for Rathmore Road at the design stage and that there was a need for clearer signs indicating entrance and exit points to the by-pass.

At member's request, Mr Young agreed to review the traffic management at Greystone Road and Rathmore Road and at the bus station and said that this would be undertaken together with the other safety aspects of the by-pass.

## **MATTERS ARISING:**

**Industrial Action by NIPSA:** Members expressed their growing concern that some members were being denied their right to be present and represent their electorate at the Planning Meetings held in the afternoon as opposed to normal evening meetings due to the continued industrial action by NIPSA. It was agreed that the concern of the Committee be conveyed to the Chief Executive of the Planning Service.

The Town Clerk tabled a letter dated 29 April 2004 from the Divisional Roads Manager on the following issues:

**Grass Edging Limavady By-Pass:** The Town Clerk reported that Roads Service had indicated it would not have been prudent to install kerbing at the time the bypass was constructed due to expected settlement and the Roads Service would consider providing kerbs to left hand road edge when resurfacing took place.

**Downland Road Roundabout:** The Town Clerk explained that a meeting had taken place with the residents, Roads Service and elected representatives from Council and that Roads Service were drawing up a proposed solution to the access difficulties and that a further meeting would take place on 20 May 2004.

**Speed Limit - Drumsurn:** The Town Clerk informed members that whilst a traffic count and speed survey would be carried out and that Road Service had indicated that, due to the sporadic nature of the existing development, it would be unlikely that a change in the speed limit could be justified.

**Speed Limit - Greystone Road:** The Town Clerk explained that Road Service had indicated that the existing 40 mph speed limit was appropriate but that a traffic count and survey would be carried out.

**Sewerage - Brisbane Road:** The Town Clerk tabled letter dated 9 April 2004 from Water Service, which explained that the provision of a sewer at Brisland Road was being re-evaluated and that Water Service expected to meet with the residents to advise on what options might be available to progress the matter further.

**Wastewater Treatment - Benone/Magilligan:** The Town Clerk reported that Water Service had confirmed in their letter dated 23 April 2004, that a comprehensive scheme to replace the 3 wastewater treatment works at Benone, Drumavalley and Aughill would commence before the end of the year, subject to a successful acquisition of land.

**Lighting - Edenmore Park/Drumachose Park/Anderson Park and Greystone Road:** The Town Clerk informed members that he had written to the Northern Ireland Housing Executive regarding their commitment to fund the installation of street lighting at rear pathways in housing estates in Limavady. He added that he had included in the letter the concerns raised by Bovally Residents on lighting at the above mentioned areas and had requested that improvement work be commenced as a matter of urgency.

# **BUILDING REGULATIONS APPLICATIONS (schedule enclosed):**

The District Chief Building Control Officer's report detailing applications approved, acknowledged and issued between 29 March and 30 April March 2004 was tabled and noted.

### **ROADS:**

**Traffic Volume - Spallan Road:** Alderman Carten raised concerns at the volume of military traffic using Spallan Road for access to and from Shackleton Barracks. The Town Clerk agreed to write to Roads Service requesting that a traffic survey be undertaking.

**Speed Limit - Lomand Road:** Councillor Cubitt suggested that a speed limit of 40 mph should be introduced in Lomand Road as there was an increasing number of houses built there. The Town Clerk agreed to write to Roads Service regarding this matter.

**Grass Verges - Edenmore Road:** At the request of Councillor Rankin, the Town Clerk agreed to write to Road Service regarding the poor state of the grass verge at Edenmore Road.

**Subsidence - Chapel Road:** Councillor Coyle commented that subsidence had occurred on the edges of Chapel Road between the speed limit and Curragh Road junction and that traffic tended to use the centre of the road which could lead to road accidents. The Town Clerk agreed to contact Roads Service to request that the road by repaired as matter of urgency.

**Traffic Damage - Burren Road:** Councillor F Brolly pointed out that Burren Road was subject to damage as a result of heavy vehicles from the adjourning sand pit. Members noted that Roads Service had carried out remedial work on the road between the bridge and the sandpit. The Town Clerk agreed to write to Roads Service requesting a major upgrade of the road.

**Disabled Parking Bays - Catherine Street:** Members welcomed the proposal by Road Service to introduce 2 disabled parking bays at Catherine Street.

**Road Repair - Foreglen Road:** Councillor A Brolly explained that she had received a letter from an elderly resident of the Borough, which highlighted that the slip road leading to Columbia Park from the Foreglen Road was in need of repair as it had deep potholes and was unsafe for those who used it. It was agreed that the Town Clerk write to Roads Service regarding the maintenance of this road.

# PUBLIC CONSULTATION DRAFT - PLANNING POLICY STATEMENT 17 CONTROL OF OUTDOOR ADVERTISEMENTS:

The Town Clerk submitted the Public Consultation Draft - Planning Policy Statement 17 Control of Outdoor Advertisements and requested comments for forwarding to the Planning Service by 18 June 2004.

### **ANY OTHER BUSINESS:**

**Geological Survey of Foyle:** The Town Clerk submitted an invitation from Mr Eamon Molloy to a seminar on a Geological Survey of the Foyle, which was to be held on Monday 10 May 2004 at 10.30 in Magee College. It was agreed that attendance at this event by any member be considered an approved duty.

**Island of Ireland Week:** It was agreed by members that Councillor Mullan, as opposed to Councillor Cubitt attend the Island of Ireland Week to be held 5 - 11 June 2004.

**Northern Area Plan - 2016:** The Town Clerk reminded members that supported Mr Raymond Harper in his endeavours to have an enforcement order removed in 2000/2001 and that his appeal had been unsuccessful. He added that MKA Planning was lobbying to have the area at Tullyhoe designated as a hamlet within the green belt between Limavady and Ballykelly and had requested Council's support in this matter. It was proposed by Alderman Dolan, seconded by Alderman Carten to endorse the case submitted by MKP Planning.
