ROADS:

Disabled Parking Bay – **Main Street, Ballykelly:** Council welcomed that Road Service were introducing a disabled parking bay on Main Street Ballykelly, in layby to the front of the Spar Shop. Members were of the opinion that a similar parking bay was needed on the other side of the street. It was pointed out that enforcement for the parking bay might be difficult.

By-Pass in Dungiven: A member pointed out that a recent consultation on Dungiven by-pass had not been well attended.

Roads - Salt Supply: It was highlighted that some members of the public were misusing salt supplies from Roads Service. It was clarified that Roads Service had confirmed that they had adequate salt to cover the current bad weather period and that forward orders were put in for January 2011. It was acknowledged that some isolated areas were still unreachable and that carers and nurses were finding it extremely difficult to get to their patients.

NOTICE OF MOTION SUBMITTED BY COUNCILLOR BUTCHER:

Councillor Butcher proposed:

"That this Council adopts a policy to assist in the winter gritting and snow clearance on footways, as determined by the Council, in order to alleviate the hazards which exist for local ratepayers in this borough and given the offer by the Department for Regional Development to provide indemnity cover in addition to grit and salt resources for distribution"

A member queried submission date for the motion and to the rules for members submitting a motion for debate at a meeting in which they chaired.

Councillor Butcher confirmed that he intended his motion to be debated at the Development Services meeting but having missed the submission deadline, the motion had been put on the agenda for the next available meeting, which was the Planning & Services meeting. It was suggested that because of anomalies around

the motion and to the fact that Council was already teasing out an agreement with Roads Service on the gritting of footpaths that the motion be withdrawn.

Councillor Butcher indicated that the motion, which had been circulated to 26 Councils had been submitted in good faith and that its intent was to tidy up loose ends around any agreement with Roads Service.

After further discussion, Councillor Butcher agreed to re-submit his motion for debate at the January 2011 Monthly meeting of Council.
