It was stated that the Retail and Markets Programme would offer assistance to existing business and market traders by helping them to upgrade their retail skills to make their business more competitive.

In response to a query raised, the Economic Development Officer stated that the Revitalisation Scheme was launched by Invest NI to provide grants to business owners to help them overhaul their shop fronts, signage and refurbish internal buildings etc. but required that some investment was required by the business owner.

After further discussion, it was also agreed that Council would write to Minister Foster to ask her to show support for the applications to Invest NI for the proposed new hotel and the Marine Hotel Ballycastle.

"That this Council welcomes the continuing commitment from the major parties in the Assembly to withhold the extension of the 1967 Act relating to abortion to the North of Ireland.

That this Council welcomes the support of all the major parties for a pregnant woman to have the option for a termination when her life is at risk.

That this Council calls on the Health Department to publish guidance to provide clarity and reassurance to medical clinicians and practitioners of their responsibilities in such circumstances.

That this Council supports the need for all agencies providing services relating to pregnant woman to operate fully within the law and to be regulated by the relevant government agency.

That this Council notes the decision of the Assembly to reject an amendment to the Criminal Justice Bill which, in the absence of the necessary guidance, could only have had the effect of ensuring that a woman whose life is at risk would not have the option for a termination.

That this Council calls on the Assembly to ensure that any legislation with regard to this important and sensitive issue is fully consulted on and not treated as an add-on in any on-going legislative process."

After discussion.

Councillor Cunningham proposed a further amendment, Seconded by Councillor Cunningham,

"That this Council notes the recent debate on amendment to the Criminal Justice Bill; reaffirms its opposition to the extension of the 1967 British Abortion Act to Northern Ireland; and calls on the Executive to ensure all providers of reproductive health services operate strictly within the law and are fully regulated."
