PCSP Update

The PCSP manager and Officer presented an update on the PCSP followed by questions and answers.

The PCSP Manager took Council through the PCSP preparation for 1st April 2015, which included Strategy Analysis and Operation Plan Commissioned, Strategy Proposals, budget, recruitment/staffing and winding up arrangements for existing Moyle PCSP.

Points discussed included the budget - Limavady being outside scope, improved and closer relationships with the general public, equal partnerships with other authorities, structure of the new council and area committees and more cohesiveness moving into the new Council.

Members thanked the PCSP for their continued hard work.

Community Small Grant Applications

After discussion, it was agreed:

- to approve the request from Cairns Residents Group for a Community Small Grant of £300 towards the cost of their Halloween event on 31st October 2014.
- (ii) to approve the request from Ballycastle Camogie Club for a Community Small Grant of £300 towards the cost of their BABL 14 (Black and Amber Biggest Loser) Scheme.

Walkway Millennium Riverside Park to Salmon Leap

Reference was made to a letter received from Bushmills Forum which listed the disadvantages of the walkway being situated on the West Bank and the advantages being situated on the East Bank and requested Council endorse the East Bank proposal and that it be included in any plans being forwarded to the new Council.

After discussion which included the original funding for the West Bank, safety issues with fishermen and lines being cast on the West Bank, flooding issues and unwanted access to housing estates on the East Bank,

Councillor Hunter proposed, Seconded by Councillor Cunningham, "That Council write a letter of endorsement to Bus

"That Council write a letter of endorsement to Bushmills Forum for the proposed Millennium Riverside Park to Salmon Leap Walkway to be situated on the East Bank."

On a vote being taken, there were 6 votes in favour of and 4 against the proposal which was carried.

Mountain Bike Trail Design Glenariffe and Ballycastle Forests

Reference was made to Councils agreement at the Council Meeting of 23rd June 2014 to proceed with the proposed Outdoor Recreation NI (ORNI) application for Glenariffe and Ballycastle Mountain Bike Trail Design with Council Match Funding. It was reported that ORNI had received an email from NITB stating that funds to operate the Tourist Innovation Fund secured through the NIE were not available for this year.

After discussion, which included the huge interest in Mountain Biking shown at the consultation process, delay possibly having a negative impact, the possibility of funds to operate the TIF being restored and whether Council could look at possibilities to proceed with this project,

Councillor Thompson proposed, Seconded by Councillor C McShane and resolved, "That Council would investigate if there was any scope in the Councils budget to facilitate this project."

<u>Causeway Coast & Glens - Consultation on Sport, Leisure Services and Facilities Strategy</u>

Due to the short time frame given for these consultations it was agreed that Council would send out presentation slides to Councillors to forward to consultants.

Councillor N McAllister left the meeting.

Sandy Port, Ballintoy Harbour

Councillor N McAllister returned to the meeting.

Discussion took place on the unauthorised sand extraction at Sandy Port, Ballintoy Harbour and that Planning Enforcement were taking steps to prevent this.
