PRESENTATION BY CHRISTIANS AGAINST POVERTY

David Kelly from CAP and Melanie Gibson from Causeway Foodbank were welcomed to the meeting.

A short DVD was shown which provided a brief overview of Causeway Foodbank Distribution Centre, how it provided nutritionally balanced food for vulnerable people and the Foodbank Voucher Distribution Scheme. It was also reported that a Foodbank Centre was to be introduced in Ballycastle by mid-June.

A comprehensive presentation was then delivered by CAP on Struggling with Debt which covered a brief overview of CAP, the process for receiving help with debt, follow up support and how faith plays its part.

Members thanked David Kelly and Melanie Gibson for their detailed presentations and the hard work that had been done to assist those people who were struggling with debt.

During questions and answers queries raised included how a person is assessed and by whom, the distribution of food parcels in the Glens, the responsibility of the outstanding debt and how CAP raises income.

PCSP Update

This was moved to the end of the Development Services Report.

Community Festivals Fund 2014-15

After discussion, it was agreed that Council would approve the recommendations of the Community Grants Assessment Panel re allocation of Community Festivals Fund Grants 2014-15 as listed in Item 1.2 of the Development Services Report.

A query was raised on item number 6 - Cushendall Boat Club as to whether a limited company was eligible to apply. It was agreed that this was to be clarified.

Tourism Events Fund

After discussion, It was agreed that Council would approve the recommendations of the Community Grants Assessment Panel re allocation of Tourism Events Fund Grants as listed in Item 1.3 of the Development Services Report.

Request from Ruairi Og CLG

After discussion, it was agreed that Council would approve retrospectively the request from Ruairi Og CLG Cushendall for a further extension to their Community Infrastructure Fund Grant for constructing a Training Ball Wall, until 30th September 2014.

Community Small Grants Applications

After discussion, it was agreed to award a Community Small Grant of:

- £300 to the Marconi Radio Group towards the hosting of a Special Ham Radio Station to run from 1st May – 28th May 2014 to mark the Giro D'Italia.
- (ii) £243 to Ballycastle Runners AC towards the cost of a 1.8m Fun Run/Walk on 8th May 2014 in celebration of the Giro D'Italia.
- (iii) £300 to the Ballintoy & District Community Development Association to host a special Giro D'Italia Community celebration in Ballintoy Village on Saturday 10th May 2014.

Good Relations Grant Applications 2014/15

Reference was made to an email received on 14th March 2014 from OFMDFM setting out recommendations for cut-off dates and the introduction of a scoring matrix.

After discussion, it was agreed that cut-off dates would not be imposed in the current financial year as policies on such issues would require to be formulated by the Shadow Council, so that the Causeway Coast and Glens Council have one agreed policy, which would come into force from April 2015.

It was also agreed that a scoring matrix would be devised to capture adherence to the 'good track record', different background groups applying together, 'hard to reach' groups and adherence to TBAUC themes, which are indicated in the recently revised Good Relations Grants application packs. The scoring matrix would be considered by a small panel of Council staff as individual applications are received and that recommendations would then be made to full Council for final approval.

Request received from Oliver McMullan MLA

Councillor McIlroy left the meeting.

Reference was made to a request received from Oliver McMullan MLA that Moyle District Council reverses its decision on not funding Glenariffe Improvements Group Application for Waterfoot Village for the Giro D'Italia.

Councillor McIlroy returned to the meeting.

After discussion, which included the £30K set aside for the Giro D'Italia, the application procedure, setting a precedence for other small villages and the Community Small Grants Scheme,

Councillor Thompson proposed,
Seconded by Councillor N McAllister and resolved,
"That Council agree retrospectively that Glenariffe Improvement Group
receive £300 for funding for Waterfoot, under the Community Small Grants
Scheme, and that this would also apply to other small villages on the Giro
D'Italia route."

Northern Ireland's Landscape Charter

Members felt that more information was required on this subject. After discussion, it was agreed that Council would invite the Department of Environment to present to Council.

Beach Management Strategy

After discussion,

HYDRAULIC FRACTURING – HEALTH IMPACT STATEMENT
