Legal and Confidential Matters - Underage Sale of Cigarette Lighter Refill Cases

Reference was made to three cases relating to the illegal sales of cigarette lighter refills to children aged 15 years of age, in the course of an underage sales test purchase exercise undertaken by Moyle District Council in November 2014.

Case 1

Reference was made to the underage sales test purchase of cigarettes exercise undertaken by the Councils Tobacco Control Officer (TCO) at approximately 12.25pm on 15th November 2014, and the illegal sale of a cigarette lighter refill to a child 15 years of age.

After discussion,

Councillor McIlroy proposed,

Seconded by Councillor Cunningham and resolved,

"It was agreed that the shop owner had fallen short in their responsibilities in exercising all due diligence, and after taking into account all available information that the shop owner be given a **Written Warning** for the illegal sale of a butane gas lighter refill canister to a young person under 18 years of age.

It was also agreed that the sales assistant who made the illegal under-age sale, had fallen short of their responsibilities in 'taking all reasonable precautions' and taking into account all available information be given a **Written Warning**."

Case 2

Reference was made to the underage sales test purchase of cigarettes exercise undertaken by the Councils Tobacco Control Officer (TCO) at approximately at 11.00am on 15th November 2014, and the illegal sale of a '151' butane gas lighter refill to a child.

After discussion,

Councillor D McAllister proposed,

Seconded by Councillor Cunningham and resolved,

"It was agreed that the shop owner had fallen short in their responsibilities in exercising all due diligence, and after taking into account all available information, that the shop owner be given a **Written Warning** for the illegal sale of a butane gas lighter refill canister to a young person under 18 years of age.

Case 3

Reference was made to the underage sales test purchase of cigarettes exercise undertaken by the Councils Tobacco Control Officer (TCO) at approximately 11.17am on 15th November 2014, and the illegal sale of a 'Swan' butane gas lighter refill to a child.

After discussion,

Councillor MA McKillop proposed,

Seconded by Councillor McIlroy and resolved,

"It was agreed that the shop owner had fallen short in their responsibilities in exercising all due diligence, and after taking into account all available information that the shop owner be given a **Written Warning** for the illegal sale of a butane gas lighter refill canister to a young person under 18 years of age.

It was also agreed that the sales assistant who made the illegal under-age sale, had fallen short of their responsibilities in 'taking all reasonable precautions' and taking into account all available information be given a **Written Warning**."

Legal and Confidential Matters - Underage Sale of cigarette Cases

Reference was made to two cases relating to the illegal sales of cigarettes to a child 15 years of age, in the course of an underage sales test purchase exercise undertaken by Moyle District Council in November 2014.

Case 1

Reference was made to the underage sales test purchase of cigarettes exercise undertaken by the Councils Tobacco Control Officer (TCO) at approximately 1.20pm on 15th November 2014, and the illegal sale of a packet of 10 Mayfair cigarettes to a child

After discussion,

Councillor D McAllister proposed, Seconded by Councillor McIlroy and resolved,

"It was agreed that the shop owner had fallen short in their responsibilities in exercising all due diligence, and after taking into account all available information that the shop owner be given a **Written Warning** for the illegal sale of cigarettes to a young person under 18 years of age.

It was also agreed that the sales assistant who made the illegal under-age sale, had fallen short of their responsibilities in 'taking all reasonable precautions' and taking into account all available information be given a **Written Warning**."

Case 2

Reference was made to the underage sales test purchase of cigarettes exercise undertaken by the Councils Tobacco Control Officer (TCO) at approximately 12:05pm on 15th November 2014, and the illegal sale of a packet of 10 Mayfair cigarettes to a child.

Discussion included non-enforcement of recommendations following the previous test exercise, the use of children in test exercises and legislation.

After discussion,

Councillor McIlroy proposed, Seconded by Councillor Cunningham,

"That the shop owner had fallen short in their responsibilities in exercising all due diligence, and after taking into account all available information, that **Legal Proceedings be instigated** against the shop owner for the illegal sale of a cigarettes to a young person under 18 years of age.

That the sales assistant who made the illegal under-age sale, had fallen short of their responsibilities in 'taking all reasonable precautions' and taking into account all available information be given a **Written Warning**."

Some members were not in agreement with the proposal.

On a vote being taken on the proposal there were 4 votes in favour of and 5 votes against the proposal which was lost.

After further discussion, which included non-enforcement of the regulations and sanctions to be imposed for a repeat offence,

Councillor McDonnell proposed, Seconded by Councillor Baird,

"That the shop owner had fallen short in their responsibilities in exercising all due diligence, and after taking into account all available information, the shop owner be given a **Final Written Warning** for the illegal sale of cigarettes to a young person under 18 years of age.

That the sales assistant who made the illegal under-age sale, had fallen short of their responsibilities in 'taking all reasonable precautions' and taking into account all available information be given a **Written Warning**."

On a vote being taken on the proposal there were 5 votes in favour of and 4 votes against the proposal which was carried.

Councillor MA McKillop left the meeting.

Proposed Arbitration, Rathlin Island Ferry Ltd and Moyle District Council

Reference was made to the proposed arbitration - Rathlin Island Ferry and Moyle District Council and Appendix 1 of the Environmental Services Report. The DES reported that no Statement of Case had yet been received and that members would be kept informed.

Councillor MA McKillop returned to the meeting.

The meeting continued out of Committee.

Ballycastle Town Market

After discussion, it was agreed that Council would grant Ballycastle Town Market permission for the market to set up on the Green and Seafront on 3rd May, 23rd-25th May, 14th June, 28th June, 12th &13th July, 19th July, 2nd August and 23rd August 2015, as per Item 2.3, Appendix 2 of the Environmental Services Report 23rd February 2015.

Hamill Terrace, Centenary Fields

After discussion, it was agreed that Council would install a commemorative item or signage to commemorate the Centenary of World I on the land at Hamill Terrace, which would then be eligible for dedication as a Centenary Field (subject to confirmation of legal documentation).

The DES reported that parts or whole of a site could be disposed of with Fields In Trust's prior consent but Council must then provide a suitable alternative of at least equal size and quality as stated in Appendix 3 of the Environmental Services Report.
