#### PRESENTATION BY NEELB – REQUEST FOR AN OUTDOOR GYM

A short film made by a group of young people from Armoy was presented to Council proposing an Outdoor Community Gym while dedicating it to the memory of Stephen Hunter 'Steve' McCooke, who won a gold medal in 1948 when he represented GBR in the Olympic Games in London. They explained that there was nowhere for the young people to go when they were too old for the play parks.

Members endorsed the efforts by the young people of Armoy and agreed to pass this endorsement on to the new Council.
