Points discussed included the increase of visitors to Ballycastle, Bushmills and Cushendall Visitors Centres, Dunseverick Path, Heritage Trail, visitors to Ballycastle Museum, Tourism Ireland - funding being received from Europe to promote Ireland as a whole, and the need for local people to benefit from the money received by the National Trust from the Carrick-a-Rede Rope Bridge.

Other issues raised included withdrawal of funding for the Rathlin Maritime Festival, directional signs to the Dark Hedges, Causeway Rambler not stopping to pick up pedestrians (item to be put on agenda for next Translink Meeting) and the need for more promotion/marketing from Causeway Coast for the Appalachian Trail.
