WE MUST LEARN FROM SUCH GREAT EVENTS AND DO EVERYTHING IN OUR POWER TO ENSURE THAT OUR COUNTRY MAINTAINS ITS FREEDOM, PEACE AND PROSPERITY FOR US AND FUTURE GENERATIONS. THE FIRST

BATTLE OF THE GREAT WAR WAS FOUGHT ON 5TH AUGUST 1914 AT LIEGE AND I CALL ON COUNCIL TO COMMEMORATE THIS DAY TO ENSURE THAT THE SUPREME SACRIFISE MADE BY OUR PEOPLE IS NEVER FORGOTTEN.

Councillor Baird proposed, Seconded by Councillor Graham, "That Council decide to commemorate this day and honour those who lost their lives."

After discussion, during which the following points were raised, a year of centenaries, need for reconciliation, WW1 being a military disaster and human catastrophe, learning a shared history, talks on Ethical Remembrance, untold stories of the time, poor of the Nations involved being used in war, not promoting war rather remembering it and not allowing it to happen again, shared heritage, differing commemorations, 1916 Easter Rising, Battle of the Somme, a measured and respectful response to all these events, many other Councils honouring people of their district and Good Relations remit.

Councillor Cunningham proposed an amendment,
Seconded by Councillor M A McKillop,
"That Council approach the decade of commemorations in a responsible and
measured way, mindful of the need to promote reconciliation, inclusivity,
historical accuracy and shared community involvement."

A recorded vote was requested by Councillor Graham,

On a recorded vote being taken on the amendment, Councillors Blaney, Cunningham and M A McKillop voted in favour of and Councillors Baird, Graham, Hunter, McDonnell and McIlroy voted against the amendment which was lost. Councillors C McShane and P McShane abstained.

On a vote being taken on the proposal Councillors Baird, Graham, Hunter, McDonnell and McIlroy voted in favour of and Councillors Blaney, Cunningham, M A McKillop, C McShane and P McShane voted against the proposal. Councillor C McShane used her casting vote against the proposal which was lost.
